STATE OF MAINE

IN THE YEAR OF OUR LORD ONE THOUSAND NINE
HUNDRED AND SEVENTEEN

AN ACT to further amend Chapter one hundred and twenty of the Private and Special Laws of eighteen hundred and ninety-nine, as amended by Chapter two hundred and thirty-three of the Private and Special Laws of nineteen hundred and thirteen, relating to the establishment of a municipal court in the town of East Livermore.

Be it enacted by the People of the State of Maine, as follows:

Section 1. Section one of Chapter one hundred and twenty of the Private and Special Laws of eighteen hundred and ninety-nine, is hereby amended by inserting after the

4 word "judge" in the fourth line, the following: 'Who shall
5 be a member of the bar of this state in good standing,' so
6 that said section as amended shall read as follows:

'Section 1. A municipal court is hereby established in and
2 for the towns of Livermore, East Livermore and Leeds, in
3 the county of Androscoggin, to be denominated the Liver-
4 more Falls Municipal Court: said court shall consist of one
5 judge, who shall be a member of the bar of this state in good
6 standing, who shall reside during his continuance in said
7 office, in said town of Livermore, East Livermore or Leeds,
8 and who shall be appointed, qualified and hold his office as
9 provided in the Constitution, and who shall be ex-officio, a
10 justice of the peace and of the quorum, and have and exer-
11 cise a concurrent authority and jurisdiction with trial jus-
12 tices over all matters and things by law within their jurisdic-
13 tion, and such authority and jurisdiction additional thereto
14 as is conferred upon him by this act.'

Sect. 2. The Governor, by and with the consent of the
2 council, shall appoint a recorder of said court, who shall
3 have served at least five years as a notary, or a justice of the
4 peace, who shall reside in said town of Livermore, East
5 Livermore or Leeds, and hold his office for the term of four
6 years. In case of the absence of the judge from the court
7 room, or when the office of the judge shall be vacant, the
8 recorder shall have and exercise all the powers of the judge,
9 including the authority to sign original writs and processes.
10 He shall receive an annual salary of two hundred dollars in

11 full for his services, payable quarterly on the first days of
12 April, July, October and January, from the treasury of
13 Androscoggin county.

Sect. 3. All acts and parts of acts inconsistent with this
2 act are hereby repealed.
