# IN THE YEAR OF OUR LORD ONE THOUSAND NINE HUNDRED AND SEVENTEEN

AN ACT to Amend Section seventy of Chapter 33 of the Revised Statutes (1916) relating to licensed marketmen.

Be it enacted by the People of the State of Maine, as follows:
Section sixty-three of chapter two hundred and six of the
Public Laws of one thousand nine hundred and thirteen is
hereby amended by inserting after the semicolon in the
twenty-second line and before the word "said" in said line
the words 'or instead of this fee, the commissioners may,
at their discretion, issue licenses authorizing the retailing
of deer as above specified, on payment of fifty cents for

8 each deer retailed;' so that said section as amended shall 9 read as follows:

'Sect. 63. Any marketman or provision dealer having an 2 established place of business in the state, may purchase and 3 have in possession at his said place of business not more 4 than three deer, lawfully killed or destroyed, or any part 5 thereof, at one time, and may sell the same at retail to his 6 local customers, and may sell the heads of such deer to 7 any licensed taxidermist; provided, however, that said mar-8 ketman or provision dealer, shall annually procure a license 9 of the commissioners of inland fisheries and game to carry 10 on said business of buying and selling deer as aforesaid; II and provided further; that said marketman shall record in 12 a book kept for that purpose, and open to the inspection of 13 inland fish and game wardens and the commissioners of 14 inland fisheries and game, the name and residence of each 15 person of whom he purchases any deer, and the date of such 16 purchase; and if any marketman or provision dealer shall 17 violate any of the provisions of this section, he shall pay a 18 fine of five hundred dollars for each offense, and be pro-19 hibited for five years thereafter from the benefits of this 20 section.

All marketmen or provision dealers licensed as aforesaid 2 shall pay to the commissioners of inland fisheries and game 3 in cities and towns of over three thousand inhabitants, five 4 dollars annually, and three dollars in all other places; or 5 instead of this fee, the commissioners may, at their dis6 cretion, issue licenses authorizing the retailing of deer as 7 above specified, on payment of fifty cents for each deer 8 retailed; said marketmen and provision dealers holding 9 these licenses shall, on December twentieth, make, sign and 10 send to the commissioners, under oath, a statement setting 11 forth in detail the number of deer by them bought, and of 12 whom bought, and the date of each purchase, during the 13 time covered by their licenses; and whoever fails to make 14 the report required in this section shall pay a fine of one 15 hundred dollars and costs.'

We, the undersigned, desire and firmly believe that this Amendment to Section sixty-three of Chapter two hundred and six of the Public Laws of one thousand nine hundred and thirteen, relating to the Inland Fish and Game Laws of the State and the Rules and Regulations of the Commissioners of the same should be passed.
