IN THE YEAR OF OUR LORD ONE THOUSAND NINE  
HUNDRED AND SEVENTEEN

AN ACT relating to the term of service of the city treasurer  
and collector of the city of Portland.

---

*Be it enacted by the People of the State of Maine, as follows:*

Section 1. The treasurer and collector of the city of  
2 Portland shall be elected by the city council, and shall hold  
3 office for the term of five years.

The present treasurer and collector of the city of Portland  
2 shall continue in office for a term of five years from the  
3 second Monday of December, 1916.

Sect. 2. Vacancies occurring in said office shall be filled  
2 by the city council for the unexpired term.

Sect. 3. All acts, parts of acts, and ordinances of the city of Portland, inconsistent with this act, are hereby repealed.
