STATE MAINE OF

IN THE YEAR OF OUR LORD ONE THOUSAND NINE HUNDRED AND SEVENTEEN

AN ACT to amend Chapter four hundred and fifty-five of the Private and Special Laws of nineteen hundred and one amended by Chapter three hundred and five of the Private and Special Laws of nineteen hundred and five, entitled "An Act to Incorporate the York Beach Village Corporation."

Be it enacted by the People of the State of Maine, as follows:

Section 1 of Chapter four hundred and fifty-five of the

- 2 Private and Special Laws of nineteen hundred and one en-
- 3 titled "An Act to incorporate the York Beach Village Cor-
- 4 poration" is hereby amended by changing its territorial

5 boundaries so as to include the territory in the Town of 6 York generally known as "Long Sands Beach," so that said 7 section, as amended, will read as follows:

'Section 1. The territory in the Town of York embraced 2 within the following boundaries, namely: Beginning at high 3 water mark on the shore of the Atlantic Ocean at the east-4 erly extremity of the corporate limits of the York Harbor 5 Village Corporation and running by the easterly limits of 6 said York Harbor Village Corporation in a northwesterly 7 direction across the beach road locally known as "York 8 Street" to the northerly side of "Long Sands" road, so 9 called; thence continuing in a northwesterly direction by and 10 along the northerly side line of said Long Sands road to II the northwesterly side line of land of the York Harbor and 12 Beach Railroad Company, being the northerly bounds of 13 said York Harbor Village Corporation territory; thence, 14 from said last named boundary, turning and running north-15 easterly by and along the northwesterly side line of said 16 railroad land to the southwesterly side line of the road 17 leading from "Long Beach" to the "New Road" so called, 18 and known as the "Webber Road;" thence running north-19 westerly by and along the southerly side of said Webber 20 road to and across the aforenamed New road to the north-21 westerly side line of said road; from thence running north-22 easterly by and along the northwesterly side line of said 23 New road to the division line between land of the heirs 24 of Elijah Blaisdell and land of David Donnell; thence run25 ning by said heirs and said Donnell's land northwesterly at 26 right angles with said New road five hundred feet to a 27 point on said line; thence turning and running northeasterly 28 parallel with the aforenamed New road and five hundred 29 feet distant therefrom to the intersection with the line form-30 ing the present bounds or limits of the present York Beach 31 Village Corporation; thence N. about 23° E. to the inter-32 section of the northwesterly side line of land of the Atlantic 33 Shore Railway Company; thence by said boundary line of 34 land of said Railway Company northerly to the center of 35 the channel of Cape Neddick River; thence following said 36 channel to the Atlantic Ocean; thence southerly, easterly 37 and westerly, as the shore line runs, to a point at low water 38 mark southeast of the point of beginning; thence from said 39 point at low water mark to the point of beginning, together 40 with the inhabiatnts thereof, is hereby created a body politic 41 and corporate by the name of the York Beach Village Cor-42 poration, with all the rights and privileges granted by the 43 laws of the state to corporations.'

Section 2 of Chapter four hundred and fifty-five of the 2 Private and Special Laws of nineteen hundred and one, 3 entitled "An Act to incorporate the York Beach Village 4 Corporation," is hereby amended by striking therefrom the 5 first two and one-half lines thereof and by adding thereto 6 certain rights, privileges and powers, so that said section, 7 as amended, will-read as follows:

'Sect. 2. Said corporation is hereby authorized and vested

2 with the power, at any legal meeting called for that purpose, 3 to apportion and designate the uses to which the money 4 received from the Town of York under the provisions of 5 Section 4 of this charter as now amended shall be put, the 6 purposes and uses for said money being among other things 7 as follows: to create and maintain a fire department with 8 all the necessary engines, equipments, appliances and ap-9 paratus for the prevention and extinguishment of fires; to 10 acquire and maintain property, buildings and structures II necessary for the use and preservation of its said fire de-12 partment property; to construct a building to be used as 13 Village Hall and to contain therein such offices and apart-14 ments, including lock-ups, as may be convenient for the ad-15 ministration of corporate rights and duties herein granted 16 and to acquire land necessary and convenient therefor, or 17 to lease, or otherwise acquire, said property, or portions 18 thereof, for said purposes; to build, maintain, and repair 19 roads, streets, ways and sidewalks; to light and sprinkle its 20 streets; to set out and care for shade trees; to improve 21 and care for public grounds as hereinafter provided; to 22 build and maintain such sewers and drains as the corpora-23 tion may vote to build in addition to those already built and 24 to be built and constructed by the Town of York; to main-25 tain a night watch or police force; to provide means for the 26 collection and removal of the offal and garbage; to protect 27 and care for the beaches; to care for and beautify that por-28 tion of the corporate territory of York Beach which may

29 hereinafter be reserved and dedicated to public uses to be 30 enjoyed in common by all the inhabitants of said York 31 Beach Village Corporation, and to that end to build roads 32 and walks upon and to said public lands; to build, repair 33 and maintain public walks, wharves and landings; to estab-34 lish a sanitary and health department; to provide and estab-35 lish a department with powers to govern and regulate build-36 ing constructions at York Beach in order to prevent the 37 erection of dangerous and unsightly buildings and struc-38 tures; to advertise the beauties, advantages and attractions 39 of York Beach as a summer resort; and to defray the ex-40 penses of all other necessary measures for the improvement 41 of said village corporation, for the better security of life 42 and property, and for the promotion of good order and quiet 43 within the corporate limits; said corporation shall have the 44 right and authority to receive, hold and manage, devises, 45 bequests and gifts for any and all of the purposes author-46 ized by this charter, and for the purposes herein named, and 47 said York Beach Village Corporation, by its proper agents, 48 may make contracts necessary and convenient for the exer-49 cise of its corporate powers.'

Section 3 of Chapter four hundred and fifty-five of the 2 private and special laws of nineteen hundred and one, en-3 titled, "An Act to incorporate the York Beach Village Cor-4 poration," is hereby amended, so that said section will read 5 as follows:

'Sect. 3. Said corporation, within its territorial limits

2 shall have, and is hereby granted all the rights, powers 3 and privileges which towns, or their municipal officers, have 4 under the provisions of the Revised Statutes and Public 5 Laws relating to drains and sewers, and all powers, duties 6 and privileges granted by said Statutes and Public Laws 7 of the State of Maine to selectmen, clerks, treasurers and 8 constables of towns are hereby respectively granted to and 9 vested in the assessors, clerk and treasurer and constables 10 and police officers of said corporation, and all powers con-II ferred and duties, penalties, and obligations imposed by said 12 statutes and by public laws upon towns and upon persons, 13 for the benefit and protection of towns and persons, and of 14 their drains, sewers and property, shall be possessed by, 15 and imposed upon, said corporation, and persons and prop-16 erty therein, for the benefit and protection of said corpora-17 tion, persons and property, and the drains, and sewers 18 thereof. Provided, however, that the assessors of said cor-19 poration shall not have power to construct drains or sewers 20 at the expense of the corporation without a vote of the cor-21 poration, at some legal meeting called therefor, authorizing 22 such construction.'

Section 4 of Chapter four hundred and fifty-five of the 2 Private and Special Laws of nineteen hundred and one, 3 amended by Chapter three hundred and five of the Private 4 and Special Laws of nineteen hundred and five, entitled, 5 "An Act to incorporate the York Beach Village Corporation," is hereby repealed, and the following shall be inserted 7 as Section 4 of the amended charter to read as follows:

'Sect. 4. On or before the first day of July annually, be-2 ginning in 1917, the Town of York shall appropriate and 3 pay over to the York Beach Village Corporation a sum of 4 money computed as follows: from the annual appropriation 5 raised by the town taxation on the estates and polls within 6 said York Beach Village Corporation for the preceding year 7 shall be deducted said corporation's proportional part, based 8 on valuation and poll tax assessment of the whole annual 9 town levy for said preceding year for state, county and 10 school taxes, salary of the town officers, reduction of town II debt, interest on town charges, appropriations for roads, 12 poor, incidentals, and any and all other town charges, and 13 fifty-five percentum of the sum thus determined, after de-14 ducting the corporation's proportion of town obligations for 15 hydrants and street lights, shall be said sum to be annually 16 paid over to said corporation as herein provided. Said sum 17 shall be expended by said corporation for its corporate pur-18 poses and duties, and payment thereof to the corporation 19 shall relieve said town of all town charges within said 20 corporation except for street lighting, hydrant service, pub-21 lic schools, public health, maintenance of poor, and con-22 struction and repair of town sewers. All the authority and 23 duties of the selectmen or road commissioner within said 24 corporation shall be exercised by said assessors; or they 25 may appoint an agent to perform the duties of road com-26 missioner.'

Section 5 of Chapter four hundred and fifty-five of the

- 2 Private and Special Laws of nineteen hundred and one, 3 entitled, "An Act to incorporate the York Beach Village 4 Corporation," is hereby repealed, and the following shall 5 be inserted as Section 5 of the amended charter to read as 6 follows:
- 'Sect. 5. Said corporation and the overseers thereof, un-2 less its doings are repugnant to the laws of this state, or to 3 its charter, shall have the same powers and duties in the 4 management of its corporate affairs that towns and the se-5 lectmen thereof now have, to be exercised and performed 6 under the same conditions, limitations and liabilities, and 7 in the same manner, that they are now exercised and per-8 formed by towns and its selectmen, including therein its 9 mode of calling and manner of conducting its corporation 10 meeting and election of officers; the statute rights to make 11 by-laws and ordinances; the right of eminent domain; the 12 statute powers to lay out and alter streets and ways within 13 its territory; the statute powers to issue licenses to run 14 places for public exhibitions and amusement; the right to 15 determine in what manner and upon what terms abuttors 16 upon the lines of its sewers and drains may enter or must 17 enter and connect with it, and may establish rules and regu-18 lations and a schedule of rates which may be collected at 19 regular periods; and all other rights, privileges, duties and 20 obligations not incompatible herewith.'

Section 6 of Chapter four hundred and fifty-five of the 2 Private and Special Laws of nineteen hundred and one,

3 entitled, "An Act to incorporate the York Beach Village 4 Corporation," is hereby amended so that said section will 5 read as follows:

'Sect. 6. Said corporation, at any legal meeting called for 2 that purpose, may vote to issue its bonds or notes to obtain 3 money to carry out each, any, or all of the objects and 4 purposes set forth in Sections 2 and 3 of this Act as now 5 amended. Said bonds or notes shall be signed by the as-6 sessor and treasurer, and shall be on such time and bear 7 such rate of interest as the corporation may deem expedient, 8 subject, however, to the limitations to towns under the Con-9 stitution of Maine limiting municipal indebtedness. And 10 in addition to the above powers of raising money said cor-11 poration may, from time to time, borrow money as a tem-12 porary loan in anticipation of the receipt of its money from 13 the town of York under Section 4 as now amended.'

Section 7 of Chapter four hundred and fifty-five of the 2 Private and Special Laws of nineteen hundred and one, 3 entitled, "An Act to incorporate the York Beach Village 4 Corporation," is hereby amended, so that said section will 5 read as follows:

'Sect. 7. The officers of said corporation shall be a clerk, 2 treasurer, three assessors, three fire wardens, and such 3 officers as the by-laws of said corporation may require. 4 Each officer shall be a resident and reside, during his term 5 of office, within the limits of said corporation. The clerk, 6 treasurer and assessors shall be chosen by ballot at the an-

7 mual meeting of said corporation, or at a special meeting 8 called for the purpose, and said other officers of said corgo poration shall be residents within the limits of said corporation, as aforesaid, and shall be selected by ballot, or other method agreed upon by a vote of the corporation. Said clerk, treasurer, and assessors shall hold office for one year, or until the next annual meeting, and thereafter until their successors are chosen and qualified, and shall severally have all the powers and authority within the limits of said corgo poration that similar officers chosen by towns now, or may have. The assessors may appoint and remove police officers and such other officers as the by-laws allow, and whose 19 selection is not otherwise provided for herein.

Said corporation, at any legal meeting, may adopt a code 2 of by-laws not repugnant to the laws of this state, nor its 3 charter, for the efficient management of its affairs. All 4 officers aforesaid shall be sworn before the clerk of a justice 5 of the peace for the faithful performance of their duties. 6 The treasurer shall give bond with such sureties as the as-7 sessors of the corporation may approve in a sum not less 8 than double the amount of money paid to said corporation 9 by said town, as set forth in Section 4 of this act, to the inhabitants of the corporation, for the faithful performance 11 of his duties, and said bond shall be approved in writing 12 by the assessors and thereafterwards deposited with and 13 retained by the clerk of the corporation. The compensation of all officers herein provided for shall be fixed by vote 15 of the corporation.

Sect. 8. Said assessors shall be the general municipal 2 officers of said corporation and shall have general charge of 3 its affairs and of the expenditure of money thereof, except 4 so far as the same may by this act be committed to other 5 officers or persons.

Sect. 9. The fire wardens shall have exclusively all the 2 power and authority, within the limits of said corporation, 3 that fire wardens have, or may have, when chosen by towns 4 in town meeting. The police officers shall have power to 5 execute all warrants and have the same power to prevent 6 public disturbances and preserve public peace within said 7 corporation as is given by the laws of this state to con-8 stables, and to restrain all infractions of, and carry into 9 effect, such by-laws as said corporation shall adopt in pur-10 suance of this act.

Sect. 10. The clerk shall record all doing and proceed2 ings at the meetings of said corporation. The clerk may
3 appoint a deputy to act in his absence in the manner pro4 vided by statute for the appointment of a clerk in the
5 absence of a town clerk; and in case of the clerk's absence,
6 death, resignation, or removal from office without having
7 made such an appointment, the assessors may appoint a
8 resident of the corporation in the manner provided by
9 statute for the appointment of a clerk by municipal officers
10 of towns.

Section II of Chapter four hundred and fifty-five of the 2 Private and Special Laws of nineteen hundred and one, en-

- 3 titled "An Act to incorporate the York Beach Village Cor-4 poration," is hereby repealed, and the following shall be 5 inserted as Section II of the amended charter to read as 6 follows:
- 'Sect. 11. Any person having his legal residence within 2 the territory aforesaid, qualified to vote for governor, sena-3 tors and representatives may be elected or appointed to any 4 office in said corporation, but shall cease to hold said office 5 whenever he ceases to be such legal voter.'

Section 12 of Chapter four hundred and fifty-five of the 2 Private and Special Laws of nineteen hundred and one, en-3 titled, "An Act to incorporate the York Beach Village Cor-4 poration," is hereby amended so that said section will read 5 as follows:

'Sect. 12. Every person having his legal residence within 2 the territory aforesaid, qualified to vote for governor, sena-3 tors and representatives, shall be a legal voter at any meet-4 ing of the corporation, and shall also be qualified to vote 5 upon the acceptance of this charter and the amendments 6 thereof, also, every person, male or female, of lawful age, 7 who owns and possesses real estate within the limits of 8 said corporation, and has owned and possessed the same for 9 at least six months prior to any election or meeting of said 10 corporation, whether resident or non-resident owner of 11 real estate, shall be a legal voter at any meeting of the 12 corporation and shall be qualified to vote upon the accept-13 ance of the charter and upon the amendments thereof if 14 they are present. The assessors of the corporation shall

15 determine who are legal voters at any meeting, and shall 16 prepare a list of said voters at least twenty-four hours be17 fore every meeting, which said list they may amend or 18 correct at any time before said meeting or during its 19 progress. The vote for the election of officers of the cor20 poration and upon any proposition at any meeting shall be 21 taken and checked by this list upon the demand of five 22 legal voters.'

Section 13 of Chapter four hundred and fifty-five of the 2 Private and Special Laws of nineteen hundred and one, en-3 titled "An Act to incorporate the York Beach Village Cor-4 poration," is hereby amended, so that said section will read 5 as follows:

'Sect. 13. This charter, as now amended and enlarged, 2 may be accepted at any time within two years from its 3 approval by the governor, except that not more than two 4 meetings for such acceptance shall be held in any one calen-5 dar year, and the first meeting for that purpose shall be 6 held on the second Monday in September, 1917. Frank E. 7 Parsons, Frank H. Ellis, J. Byron Paul and Charles L. 8 Worthen, or any one of them, are hereby authorized to call 9 any meeting of said corporation to act on the acceptance 10 of this charter, and to notify all persons qualified to vote 11 at said meeting, to assemble at some suitable time and place 12 within the limits of said corporation, by posting up notices 13 thereof in two public and conspicuous places within said 14 limits seven days at least before the time of said meeting;

15 and any one of said persons above named is authorized to 16 preside at said meeting until after its organization and until 17 after a clerk and moderator of the meeting shall have been 18 chosen by ballot and sworn. At all meetings of said cor-19 poration a moderator shall be chosen in the manner and 20 with the same powers as in town meetings.'

Section 14 of Chapter four hundred and fifty-five of the 2 private and special laws of nineteen hundred and one, en-3 titled "An Act to incorporate the York Beach Village Cor-4 poration," is hereby amended, so that said section will read 5 as follows:

'Sect. 14. Said assessors shall call all subsequent meet-2 ings of the corporation by posting up notices thereof, in two 3 public and conspicuous places within the limits of said cor-4 poration, signed by them and stating the time and place of 5 each meeting, seven days at least before the time appointed 6 for the meeting. All notices shall state in distinct article 7 the business to be acted upon at the meeting, and no other 8 business shall be then and there acted upon. When ten or 9 more voters in writing request the assessors to insert a par-10 ticular article in any notice they shall insert it in their next II notice issued, or shall call a special meeting for the consid-12 eration thereof to be held within thirty days after the filing 13 of said written request. The annual meeting for the elec-14 tion of officers, excepting perhaps the first meeting for the 15 election of officers, shall be held on the second Monday of 16 September in each year. In case the assessors unreasonably

17 neglect or refuse to call a meeting, any justice of the peace 18 may call a meeting of the corporation on petition of ten 19 legal voters, by posting up notices in the manner herein pro20 vided.'

Sect. 15. At any first meeting of said corporation called 2 in pursuance to section thirteen of this act, the legal voters 3 within said corporate limits shall by ballot vote on the question of accepting this charter, and if a majority of such 5 voters present and voting at said meeting shall vote in favor 6 of its acceptance, then this act shall take effect and the corporation shall proceed to organize and choose its officers, 8 and may adopt a code of by-laws.

Section 16 of chapter four hundred and fifty-five of the 2 private and special laws of nineteen hundred and one, en-3 titled "An Act to incorporate the York Beach Village Cor-4 poration," is hereby amended, so that said section will read 5 as follows:

'Sect. 16. This amended act and charter when accepted by 2 a majority of the voters of said corporation, as aforesaid, 3 then shall take and have complete effect in all its parts; and 4 all parts of the original charter and act of chapter four 5 hundred and fifty-five of the private and special laws of 6 nineteen hundred and one, entitled, "An Act to incorporate 7 the York Beach Village Corporation," amended by chapter 8 three hundred and five of the private and special laws of 9 nineteen hundred and five, inconsistent with and repugnant 10 to this charter as now amended, are hereby repealed; and

II the term of office of all elective and appointed officers of 12 the York Beach Village Corporation now holding office 13 under the provision of said chapter four hundred and fifty-14 five of the private and special laws of nineteen hundred and 15 one, shall end, expire and terminate when this amended 16 charter is accepted, as aforesaid, and the several officers of 17 the corporation are elected, as provided by the provisions of 18 this amended charter. Whatever sum or sums of money 19 may be appropriated by the town of York and may have 20 been used and expended within the limits of said corpora-21 tion for town purposes outside of and other than those spec-22 ially imposed upon said town by section 4 of this act, and 23 whatever sum or sums of money the town of York may 24 have paid over to said corporation during the year in which 25 this amended charter is accepted and before it is accepted, 26 shall be deducted from the amount payable to said corpora-27 tion for said year in which this charter is accepted as pro-28 vided in section 4 of this charter, so that said corporation 29 the year its charter is accepted shall receive the total amount 30 payable to it in money, as provided in said section 4, or part 31 thereof in services already performed and expenditures al-32 ready made and the balance thereof in money, as the case 33 may be.

We, the undersigned, legal voters of York, residents within the limits of said corporation, affix our names as petitioners.
