STATE OF MAINE

IN THE YEAR OF OUR LORD ONE THOUSAND NINE HUNDRED AND SEVENTEEN

AN ACT granting Chas. H. Scott the right to maintain a ferry across Eggemoggin Reach in Hancock County.

Be it enacted by the People of the State of Maine, as follows:

Section 1. Charles H. Scott of Deer Isle, Hancock county,

- 2 his associates and assigns are hereby authorized to establish
- 3 and maintain a ferry for the space of ten years, across
- 4 Eggemoggin Reach, between the towns of Deer Isle and
- 5 Sedgwick, in said Hancock county, from the terminus of
- 6 the road now existing on the Deer Isle shore, near the steam-
- 7 boat wharf of the Maine Central Railroad, and the terminus
- 8 of the road now existing on the Sedgwick shore, near wharf
- 9 of the Eastern Steamship Company, at Sargentville, with the

- 10 right to keep and maintain suitable boats to be propelled by
- 11 wire and trucks, oars, sails, steam, or some other power, for
- 12 the safe conveyance and transportation of passengers, teams,
- 13 animals, carriages, motor propelled vehicles, and freight.
 - Sect. 2. The rate of toll at said ferry shall be established
 - 2 from time to time by the county commissioners of said coun-
 - 3 ty of Hancock.
 - Sect. 3. Any person who keeps a ferry contrary to the
 - 2 provisions of this act, or who transports passengers, teams,
 - 3 animals, carriages, motor propelled vehicles, or freight be-
 - 4 tween said towns of Deer Isle and Sedgwick, across said
 - 5 Eggemoggin Reach, within a statute mile above or below
 - 6 the ferry established by this act, for hire a boat or other
 - 7 craft for such purpose, forfeits four dollars for each day
- 8 such ferry is kept or for each time of transportation, the
- 9 same to be recovered by said Scott or his associates or as-
- 10 signs, to their use in an action on the case. Provided, how-
- II ever, that the carrier of the United States mail between Sar-
- 12 gentville and Deer Isle, shall have the right to carry passen-
- 13 gers and freight for hire, within the limits of said ferry,
- 14 while actually engaged in the performance of his duties, as
- 15 such carrier on his regular trips.
 - Sect. 4. Said Scott, or his associates or assigns, shall give
 - 2 to the commissioners of said county a bond for the faithful
 - 3 performance of his duties under this act, in such sum and
- 4 with such sureties as may be approved by said commissioners.
