#### STATE OF MAINE

# IN THE YEAR OF OUR LORD ONE THOUSAND NINE HUNDRED AND SEVENTEEN

RESOLVE in favor of Patrick A. Galvin of Auburn.

Resolved, That there be paid to Patrick A. Galvin of

- 2 Auburn, in the county of Androscoggin, and State of Maine,
- 3 the sum of fifteen dollars per month payable quarterly from
- 4 the fund appropriated for military pensions beginning Jan-
- 5 uary first, nineteen hundred and seventeen, and continuing
- 6 during the pleasure of the Legislature and until otherwise
- 7 ordered.

In lieu of the state aid of eight dollars per month now received.



#### STATEMENT OF FACTS.

In case of Patrick A. Galvin of Auburn, County of Androscoggin, and State of Maine, now sixty-two years of age, who served as a private in Co. C, First Maine Regt. Volunteer Infantry, during the Spanish-American War.

While serving in the First Maine Regt., near Ravena, New York, the said Galvin was overcome by heat and suffered sunstroke, also while on the march from Chickamauga to Ringgold that the said Galvin was prostrated by heat stroke and was transported to Ringgold by ambulance and was there treated the later part of August, 1898, by James B. O'Neill, physician. That the said Galvin has become blind in one eye and the other is becoming affected. That he has vertigo or dizziness of the head, and is unable to do manual labor. He is now drawing a United States pension of \$17.00 per month. He is a widower living alone, his expenses per month, including room, board, clothing, washing and mending, aggregate thirty-five dollars per month. He has no property, real or personal.
