STATE OF MAINE

IN THE YEAR OF OUR LORD ONE THOUSAND NINE. HUNDRED AND SEVENTEEN

AN ACT to amend chapter one hundred and thirty-two, of the Private and Special Laws of nineteen hundred and thirteen, relating to the Ferry between Indian Island, so-called, and the City of Old Town.

Section 1. Section two of chapter one hundred and thirty-2 two, of the Private and Special Laws of nineteen hundred 3 and thirteen, is hereby amended by striking out the word 4 "April," in the seventh line thereof and inserting in place 5 thereof the word 'March,' so that said section as amended

Be it enacted by the People of the State of Maine, as follows:

6 shall read as follows:

- 'Sect. 2. The following rates of toll are hereby established 2 for passengers: for each passenger a resident upon Indian 3 Island and each member of said Penobscot tribe of Indians 4 wherever resident, the sum of two cents; for all other passengers, five cents each; the rate of toll for each article of 6 freight or baggage shall be established by the said tribe at 7 their annual meeting held on the first Monday in March of 8 each year by a majority vote of the members of the tribe 9 attending such meeting.'
- Sect. 2. Section five of said chapter one hundred and 2 thirty-two, is hereby amended by striking out in the second 3 line thereof the word "April," and inserting in place thereof 4 the word 'March'; also by adding to said section the follow-5 ing words: 'No such ferry man shall be eligible for election 6 in any two successive years. No person shall operate the 7 ferry boat at such ferry who is not a member of the Penob-8 scot Tribe of Indians and any person not a member of said 9 tribe operating said ferry boat shall be fined not less than 10 five dollars nor more than twenty dollars for each offense;' 11 so that as amended said section shall read as follows:
 - 'Sect. 5. The members of the said tribe shall at their an-2 nual meeting held on the first Monday in March of each 3 year, elect by majority vote a suitable ferryman who shall 4 be in charge of said ferry during the following year, such 5 election being however subject to the approval of the agent 6 of the tribe. No such ferryman shall be eligible for election 7 in any two successive years. No person shall operate the

8 ferry boat at such ferry who is not a member of the Penob-9 scot Tribe of Indians and any person not a member of said 10 tribe operating said ferry boat shall be fined not less than 11 five dollars nor more than twenty dollars for each offense.'
