STATE OF MAINE

IN THE YEAR OF OUR LORD ONE THOSAND NINE HUNDRED AND SEVENTEEN

AN ACT amending Chapter 121 of the Private and Special Laws of 1915 establishing a closed time on lobsters in Machias Bay and adjacent waters in the County of Washington.

Be it enacted by the People of the State of Maine, as follows:

Section I of Chapter 12I of the Private and Special Laws

of 1915 is hereby amended by striking out therefrom the following words: "Thence to the nearest point of the mainland in the town of Cutler; thence following the line of said
mainland to the point thereof nearest the island known as

- 6 The Spindle near the entrance to Cross Island Narrows;
- 7 thence to The Spindle and continuing in a direct line to the

8 easternmost point of the island known as Double Head Shots 9 and continuing thence due south for a distance of three 10 miles;" and inserting therein in place thereof the following 11 words: 'Thence running south southwest two and three-12 fourths (234) miles; thence south southeast one-half (½) 13 mile; thence south by west three-fourths (34) west to the 14 three mile limit; thence by said three mile limit to a point 15 three (3) miles due south from the casternmost point of 16 Camp Island, otherwise known as The Brothers;' so that 17 said section as amended shall read as follows:

'Section 1. No person shall take, catch, kill, or destroy any 2 lobsters between the first day of July and the thirty-first day 3 of August, both inclusive, in each year, in any of the waters 4 of Machias bay, or waters adjacent thereto, between the fol-5 lowing described lines to wit: the easterly line beginning at 6 a point where the dividing line between the towns of Ma-7 chiasport and Whiting strikes the shore of Holmes bay, and 8 continuing on said dividing line to Township rock, so-called, 9 in said Holmes bay; thence running south southwest two and 10 three-fourth (23/4) miles; thence south southeast one-half II $(\frac{1}{2})$ mile; thence south by west three-fourths $(\frac{3}{4})$ west to 12 the three mile limit; thence by said three mile limit to a point 13 three (3) miles due south from the easternmost point of 14 Camp Island, otherwise known as The Brothers; the wester-15 ly line beginning at Fan Island at the mouth of Little Ken-16 nebec river, and running southerly to Hickey island; thence 17 southerly to the easternmost point of Camp Island, other18 wise known as The Brothers, and continuing thence due 19 south for a distance of three miles; and no person shall set a 20 trap within said waters for the purpose of taking, catching, 21 killing or destroying any lobsters between said dates, under 22 a penalty of one dollar for each lobster so taken, caught, 23 killed or destroyed, and under a penalty of five dollars for 24 each lobster trap so set for said purpose. Provided, how-25 ever, that this act shall not apply to lobsters confined in cars 26 and not taken or caught by traps set in violation hereof.'
