STATE OF MAINE

IN THE YEAR OF OUR LORD ONE THOUSAND NINE
HUNDRED AND SEVENTEEN

RESOLVE in favor of several academies, institutes, seminaries
and colleges for maintenance and for repairs and im-
provements.

Resolved: That there be and hereby is appropriated in
2 favor of the academies, institutes, seminaries and colleges
3 hereinafter listed the sum of thirteen thousand three hun-
4 dred fifty dollars for the year nineteen hundred seventeen,
5 and the sum of eleven thousand eight hundred fifty dollars
6 for the year nineteen hundred eighteen, said sums to be ex-
7 pended under the direction of the board of trustees of said
8 institutions to the amount and for the purposes indicated in
9 the following schedule.
