STATE OF MAINE

IN THE YEAR OF OUR LORD ONE THOUSAND NINE HUNDRED AND SEVENTEEN

AN ACT to amend Section fifty-one of Chapter eighty-two of the Revised Statutes in relation to trial terms of the Supreme Judicial Court.

Be it enacted by the People of the State of Maine, as follows:

Section fifty-one of Chapter eighty-two of the Revised

- 2 Statutes is hereby amended by striking out the words "sec-
- 3 ond Tuesdays of April and October" in the twenty-fifth line
- 4 of said section, and substituting therefor the words, 'fourth
- 5 Tuesday of April and second Tuesday of October,' so that
- 6 said section as amended shall read as follows:

'Sect. 51. For the trial of civil actions and of persons

- 2 accused of offenses, and for the transaction of all other
- 3 business, except cases named in Section forty-six, the court
- 4 shall be held annually by one justice, at the following places
- 5 and times; and the justices shall so hold said terms, under
- 6 the direction of the chief justice, that their services shall be
- 7 divided to each county as equally as may be.

In the County of Androscoggin, at Auburn, on the third 2 Tuesdays of January, April and September:—

Aroostook, at Houlton, on the third Tuesdays of April

- 2 and November, for civil and criminal business, and at Cari-
- 3 bou on the first Tuesdays of February and September, for
- 4 civil business only:-

Cumberland, at Portland, on the second Tuesdays of Jan-2 uary, April and October, for civil business:—

Franklin, at Farmington, on the first Tuesday of Febru-

- 2 ary, third Tuesday of May, and the second Tuesday of
- 3 September; the May term shall be held without a grand
- 4 jury and with but one traverse jury, unless a justice of
- 5 said court shall otherwise specially order, in which case the
- 6 clerk shall send venires for the requisite number of traverse
- 7 jurors, and shall summon the grand jury of the preceding
- 8 term, as the terms of said order may require. All recog-
- 9 nizances from municipal courts and trial justices in which
- 10 parties are held to await the action of the grand jury, made
- 11 returnable to said May term, shall, when no grand jury is
- 12 in attendance, be continued to and have day in the next
- 13 term of the court held in said county:-

Hancock, at Ellsworth, on the fourth Tuesday of April 2 and second Tuesday of October:—

Kennebec, at Augusta, on the first Tuesday of March, and 2 the second Tuesday of October, for civil business:—

Knox, at Rockland, on the second Tuesday of January,

- 2 first Tuesday of April, and the second Tuesday of Septem-
- 3 ber :-

Lincoln, at Wiscasset, on the fourth Tuesdays of April 2 and October:—

Oxford, at Paris, on the second Tuesdays of March and

- 2 October, and at Rumford Falls, in the town of Rumford,
- 3 on the second Tuesday of May. The May term shall be
- 4 held without a grand jury unless specially ordered by any
- 5 judge of said court. All recognizances and other criminal
- 6 processes made returnable to and to have day in said May
- 7 term, when no criminal business is transacted, shall be con-
- 8 tinued to and have day in the next term of said court held
- 9 in said county:—

Penobscot, at Bangor, on the first Tuesdays of January,

- 2 April and October, for civil business, and on the first Tues-
- 3 days of February and September, for criminal business:-

Piscataquis, at Dover, on the second Tuesdays of March

2 and September:-

Sagadahoc, at Bath, on the fourth Tuesday of January,

2 and the second Tuesdays of May and October:-

Somerset, at Skowhegan, on the fourth Tuesday of Janu-2 ary, first Tuesday of April, and the third Tuesday of Sep-

3 tember:-

Waldo, at Belfast, on the first Tuesday of January, and 2 the third Tuesday of April and the fourth Tuesday of Sep-3 tember.

Washington, at Machias, on the first Tuesday of January 2 and the second Tuesday of October, and at Calais on the 3 first Tuesday of May.

York, at Saco, on the first Tuesday of January, and at Al-2 fred on the first Tuesday of May and the third Tuesday of 3 September.
