# STATE OF MAINE

### IN THE YEAR OF OUR LORD ONE THOUSAND NINE. HUNDRED AND SEVENTEEN

AN ACT to Increase the Salary of the Judge of the Municipal Court of Dexter.

Be it enacted by the People of the State of Maine, as follows: Section fourteen of chapter two hundred and sixty of the 2 private and special laws of eighteen hundred and eighty-3 three as amended by chapter three hundred twenty-four of 4 the private and special laws of nineteen hundred seven is 5 hereby further amended, as follows:

By striking out of the eleventh and twelfth lines of said 2 section the words "and for providing all necessary blanks for 3 the use of said court," and by striking out in the twelfth line

4 of said section the word "five" and inserting in the place 5 thereof the word 'six' and by adding to the end of said sec-6 tion the following: 'it shall be the duty of the county com-7 missioners of the county of Penobscot to furnish and pro-8 vide at the expense of said county, all books, blanks, and all 9 necessary stationery and supplies required for the use of the 10 municipal court in the town of Dexter in the transaction of 11 the civil and criminal business of said court, including 12 proper books for the record of all cases arising in said court, 13 at a cost not exceeding thirty dollars per year,' so that said 14 section as amended shall read as follows:

'Sect. 14. The judge of said court may demand and 2 receive the same fees allowed to trial justices for like ser-3 vices, except that he may demand and receive for a com-4 plaint and warrant in criminal cases, one dollar; for the 5 entry of a civil action, fifty cents; and for the trial of an 6 issue, civil or criminal, two dollars for the first day and one 7 dollar for each day after the first occupied in such trial, to 8 be paid to him by the plaintiff in civil cases, before trial, who 9 shall recover the same as costs if he prevail in the suit; and 10 the said judge shall receive as full compensation for his ser-II vices including the keeping of the records of said court, a 12 salary of six hundred dollars a year, to be paid quarterly 13 from the treasury of the county of Penobscot. A condition 14 preceding the payment of said salary as aforesaid, shall be 15 the rendering by said judge of a correct and detailed state-16 ment to the county commissioners, and the payment over by 17 said judge to the county treasurer, of all fees, both civil and 18 criminal, collected by said municipal court for the preceding 19 quarter or fractional part thereof. It shall be the duty of 20 the county commissioners of the county of Penobscot to fur-21 nish and provide at the expense of said county, all books, 22 blanks, and all necessary stationery and supplies required for 23 the use of the municipal court in the town of Dexter, in the 24 transaction of the civil and criminal business of said court, 25 including proper books for the record of all cases arising in 26 said court at a cost not exceeding thirty dollars per year.'
