STATE OF MAINE

IN THE YEAR OF OUR LORD ONE THOUSAND NINE HUNDRED AND SEVENTEEN

AN ACT to authorize voters absent from the city, town and plantation in which they are qualified to vote, to vote therein by having their ballot delivered by mail to the city, town or plantation clerk on election day and to regulate such manner of voting.

Be it enacted by the people of the State of Maine, as follows:

Section 1. The secretary of state, in addition to the 2 ballots now required to be sent to the several city, town and

- 3 plantation clerks, shall prepare and transmit to such clerk
- 4 so that it shall be received by him not less than six days
- 5 prior to any general state or federal election a package of

6 not less than ten per cent. of the total number of ballots 7 now provided by law to be sent to such city, town or planta-8 tion clerk. The ballots so sent shall be sealed and have 9 stamped, printed or written on the outside of the cover 10 thereof the words "Ballots for Absent Voters." Said pack-11 age shall also have thereon the certificate of the Secretary 12 of State setting forth the exact number of ballots said 13 package contains and the Secretary of State shall keep a 14 record thereof.

- Sect. 2. The seal on said package shall not be broken by the 2 city, town or plantation clerk to whom the same is sent, 3 except for the purpose of sending or actually delivering a 4 ballot to some person properly applying therefor. Said city, 5 town or plantation clerk, upon breaking the seal and opening 6 the package of ballots so received, shall count the same and 7 enter the number so received upon a book which he shall 8 keep as a public record for that purpose. In said book shall 9 also be kept a record of the names and addresses of all 10 persons applying for such ballots and the time when such 11 ballots are mailed or delivered to the applicant. In such 12 book shall also be kept a record of the time including the 13 hour and minute of the receipt of any envelope supposed to 14 inclose an absent voter's ballot.
 - Sect. 3. Any person entitled and duly qualified to vote 2 in any city, town or plantation in this state at any general 3 state or presidential election who is absent from such city, 4 town or plantation on the day such general election is held

5 may vote therein by delivering his ballot in person prior to 6 election day or by having his ballot delivered by mail to the 6 city, town or plantation clerk as the case may be, and by 7 said clerk deposited in the ballot box of the proper voting 8 place, ward or precinct thereof before the polls are closed 9 as required by law, by complying with the provisions of this 10 act.

Sect. 4. A person entitled and duly qualified to vote in 2 any city, town or plantation at any such general election 3 may, not more than thirty nor less than three days before 4 the day of the holding of such election make application in 5 writing subscribed by him to said city, town or plantation 6 clerk for a ballot or ballots to be delivered to him for the 7 purpose of absent voting which application shall be on a 8 blank furnished him by such city, town or plantation clerk 9 and in form as follows:

	Sect. 5. Upon receipt of such application or as soon
2	thereafter as may be, the city, town or plantation clerk shall
3	ascertain if such applicant is or probably will be a duly
4	qualified voter and entitled to vote at such general election
5	in said city, town or plantation, and if so found, said clerk
6	as soon thereafter as the ballots to be used at such general
7	election are delivered to him, shall deliver to such applicant
8	in person or by mail, postage prepaid, as hereinafter pro-
9	vided, directed to the address given in the application, one
10	each of the ballots to be used at such general election, one
11	"Voters Certificate," one "Ballot Envelope" and one
12	"Return Envelope" hereinafter described, and shall there-
13	upon endorse upon the back of such application in the
14	following form:

Sect. 6. The applicant shall pay to the city, town or plan-2 tation clerk a fee of fifty cents. The money so received 3 by said clerk shall be kept in a separate fund and shall be 4 expended by said clerk in paying the postage and expenses 5 hereinafter provided for transmitting and depositing said 6 ballot.

Sect. 7. The said city, town or plantation clerk shall mail 2 prepaid, or deliver in person to the applicant a voter's cer3 tificate and two envelopes. One envelope shall be large 4 enough to contain the ballot or ballots folded in the same 5 manner as to be deposited in the ballot box, and shall be 6 known as the "Ballot Envelope." One envelope shall be 7 sufficiently larger than the "Ballot Envelope" to conveniently 8 inclose and contain the same and shall be known as the 9 "Return Envelope" hereinafter described. The said city, 10 town or plantation clerk shall cause said return envelope 11 to be addressed to such city, town or plantation clerk of 12 such city, town or plantation in which such applicant is 13 entitled to vote. Such address shall be in substantial con14 formity to the following illustration.

If the postoffice address of such city, town or plantation 2 clerk be other than the name of such city, town or planta-

3 tion the proper postoffice address shall be printed or writ-4 ten on said envelope. Such clerk may vary such form for 5 addressing the return envelope as the facts may require, 6 but shall adopt such form of address and place as will best 7 insure the prompt delivery of such envelope and contents 8 on or before election day.

Sect. 8. The said city, town or plantation clerk shall also 2 affix to said return envelope postage stamps sufficient in 3 amount to pay the postage on said "Return Envelope," after 4 the Ballot, Ballot Envelope and voter's certificate herein 5 prescribed have been enclosed therein, from any postoffice 6 within the territorial limits of the United States, to the 7 place to which it is addressed. He shall also place thereon 8 a ten-cent Special Delivery stamp, or if a Special Delivery 9 stamp be not obtainable, additional postage stamps aggre-10 gating in amount to ten cents, in which latter case he shall 11 also write or stamp on the address side of such envelope 12 in a conspicuous place the words "Special Delivery."

Whenever said applicant sets out in his application for 2 ballots a postoffice address in the Dominion of Canada to 3 which said ballots are to be sent the fee to be paid to the 4 city, town or plantation clerk shall be the sum of thirty-5 eight cents and said clerk shall not place on the return en-6 velope a postage stamp or a special delivery stamp as other-7 wise required.

Sect. 9. The said city, town or plantation clerk shall also 2 furnish to the applicant with the ballot a voter's certificate,

3 which shall be substantially in the following form, where 4 the applicant is a resident of a city divided into wards or 5 precincts.

- Sect. 13. Printed on the back of the Voters Certificate 2 shall be the following directions to voters, to-wit:

DIRECTIONS TO VOTERS.

- (A) You may mark and mail your ballot at any place 2 within the United States, or the Dominion of Canada.
- (B) The ballot must be marked and sealed in the "Ballot
 2 Envelope" in the presence of an attesting witness, but in
 3 such manner as to prevent such witness or any other per4 son from knowing or learning how you have voted as to
- (C) After marking and enclosing ballot in the Ballot En-2 velope you and attesting witness must each sign your re-3 spective names to the "Voters Certificate."

5 any candidate or proposition.

- (D) Do not put "Voters Certificate" in "Ballot Enve-2 lope" but enclose same in "Return Envelope."
- (E) Enclose "Ballot Envelope" and "Voters Certificate" 2 in "Return Envelope," seal the latter, having the attesting 3 witness sign certificate on back of "Return Envelope" and 4 then deposit same in the post office or government mail box 5 or railway mail car.
- (F) The ballot may be marked and mailed at any time 2 after you receive it from the city, town or plantation clerk; 3 it should however, be marked and mailed so as to arrive at

- 4 your voting place on or before election day. If not there 5 by that day before the polls close it will not be counted.
- (G) The attesting witness who signs the "Voters Certi-2 ficate" must also sign the certificate on the back of the "Re-3 turn Envelope."
- (H) Fold each ballot separately before placing in "Bal2 lot Envelope," fold so that cross marks can not be seen
 3 without unfolding, but so that facsimile signature of Sec4 retary of State, appearing on the back of the ballot, can be
 5 seen without unfolding the ballot.
- Sect. 14. The city, town or plantation clerk shall upon 2 the receipt of such return envelope indorse thereon the hour 3 and minute of such delivery and shall make a record of 4 all such envelopes so received and on election day after the 5 polls are opened and before they are closed, either by him-6 self, his deputy or some person by him duly authorized, 7 convey in person to the polls or places for voting, and shall 8 appear before the election office of such voting place and 9 shall show to the election officers the certificate on said 10 return envelope and shall give the name of the absent voter II whose vote he wishes to cast to one of the ballot clerks, 12 who shall thereupon announce in a loud and distinct tone 13 of voice, clear and audible, and thereafterwards the words, 14 "absent voter" and if such name is found upon the check 15 list by the ballot clerk having charge thereof he shall like-16 wise repeat said name and thereupon said city, town or 17 plantation clerk or person by him duly authorized shall break

the seal upon said return envelope and shall take therefrom the envelope marked "Ballot Envelope." Thereupon such coity, town or plantation clerk shall break the seal on said ballot envelope and without unfolding said ballot or examining it himself or exposing it to the view of any person so as to show the way said ballot is marked shall deposit the ballot in the ballot box with the other ballots.

Sect. 15. The city, town or plantation clerk shall cause 2 to be prepared and printed at the expense of said city, town 3 or plantation, for use at any general state or federal election a sufficient number of ballot envelopes, return enve-5 lopes, and voters certificates printed in such form as to 6 comply with the provisions of this act.

Sect. 16. It shall be unlawful for any person after re2 ceiving an absent voter's ballot, upon application filed as
3 herein provided, to use said ballot for any other purpose
4 than specified in this act, or deliver or furnish said ballot
5 to any other persons.

Whoever violates this section shall, upon conviction there-2 of, be punished by fine of \$50 and costs of prosecution and 3 in addition thereto by imprisonment of thirty days in jail.

Any city, town or plantation clerk who conceals any appli-2 cation by him received, fails to promptly deliver the ballots 3 and envelopes to any applicant entitled to receive the same, 4 conceals or withholds any ballot by him received in time 5 for depositing the same, or fails to deposit said ballot in 6 the appropriate voting place according to the provisions of 7 this act shall, upon conviction thereof, be punished by a 8 fine of \$100 and in addition thereto by imprisonment of 9 sixty days in jail.
