STATE OF MAINE

IN THE YEAR OF OUR LORD ONE THOUSAND NINE HUNDRED AND SEVENTEEN

AN ACT to amend Section 19, Chapter 117 of the Revised Statutes of Maine, relating to the banking department.

Be it enacted by the People of the State of Maine, as follows:
Section 1. Amend Sec. 19, Chap. 117 of the Revised
2 Statutes by striking out in the second line of said section the
3 words "Two thousand five hundred" and in place thereof in4 serting the words 'four thousand'; also amend said section
5 by striking out the word "two" in the seventh line of said
6 section and in place thereof inserting the word 'one'; also
7 amend said section by striking out the word "commissioners"

8 in the last line of the first paragraph and in place thereof 9 inserting the word 'commissioner.' Also further amend 10 said section by adding after the word "commissioner," as 11 amended, in the last line of said paragraph, the following 12 'And two of said clerks may be designated as examiners.' 13 Also further amend said section by striking out the last three 14 lines of said section, being the second paragraph of said sec-15 tion, and in place thereof inserting the following: 'The 16 deputy bank commissioner shall perform the duties of the 17 bank commissioner whenever the latter shall be absent from 18 the state or when directed by the bank commissioner. The 19 deputy bank commissioner shall receive an annual salary of 20 twenty-two hundred dollars; one examiner shall receive an 21 annual salary of eighteen hundred dollars, and one 22 examiner shall receive an annual salary of fifteen hundred The deputy bank commissioner and the two 23 dollars. 24 examiners shall receive their actual traveling expenses 25 incurred in the performance of their official duties, the pay-26 ment of which shall be subject to the approval of the 27 Governor and Council,' so that said section as amended shall 28 read as follows:

'Sect. 19. The bank commissioner shall receive an annual 2 salary of four thousand dollars; he shall receive his actual 3 traveling expenses incurred in the performance of his 4 official duties, and the reasonable and necessary expenses of 5 his office, the payment of which shall be subject to the 6 approval of the Governor and Council. He may employ at

7 the expense of the state one or more clerks, as the business 8 of the office may require, one of whom may be designated as 9 deputy bank commissioner, and two of said clerks may be 10 designated as examiners.

'The deputy bank commissioner shall perform the duties of 2 the bank commissioner whenever the latter shall be absent 3 from the state or when directed by the bank commissioner. 4 The deputy bank commissioner shall receive an annual salary 5 of twenty-two hundred dollars; one examiner shall receive 6 an annual salary of eighteen hundred dollars, and one 7 examiner shall receive an annual salary of fifteen hundred 8 dollars. The deputy bank commissioner and the two 9 examiners shall receive their actual traveling expenses 10 incurred in the performance of their official duties, the pay-11 ment of which shall be subject to the approval of the 12 Governor and Council.'
