STATE OF MAINE

IN THE YEAR OF OUR LORD ONE THOUSAND NINE HUNDRED AND SEVENTEEN

RESOLVE in favor of the state hospitals for maintenance and other purposes for the years nineteen hundred seventeen and nineteen hundred eighteen.

Resolved, That there be, and hereby is, appropriated.

For the Augusta State Hospital:

For personal services, namely, for salaries and wages of 2 all officers and employees except those wholly engaged in 3 repairs of buildings and equipment, for the year nineteen 4 hundred seventeen, the sum of ninety-five thousand (\$95,-

- 5 000.00) dollars, and for the year nineteen hundred eight-
- 6 een, the sum of ninety-seven thousand (\$97,000.00) dollars.

For food supplies, namely, all articles of food, for the year 2 nineteen hundred seventeen, the sum of one hundred and 3 eleven thousand (\$111,000.00) dollars, and for the year 4 nineteen hundred eighteen, the sum of one hundred and 5 seventeen thousand (\$117,000.00) dollars.

For clothing, namely, all articles of personal clothing and 2 materials for making the same, for the year nineteen hun-3 dred seventeen, the sum of thirteen thousand (\$13,000.00) 4 dollars, and for the year nineteen hundred eighteen, the 5 sum of thirteen thousand (\$13,000.00) dollars.

For repairs and equipment, namely, all materials and sup2 plies required for upkeep of grounds, buildings and attached
3 fixtures; all additions to and repairs and replacements of
4 furniture and equipment, including farm equipment and
5 livestock, and all personal services rendered wholly in con6 nection with repair work, for the year nineteen hundred
7 seventeen, the sum of thirty-five thousand one hundred and
8 twenty-three (\$35,123.00) dollars, and for the year nine9 teen hundred eighteen, the sum of thirty-six thousand two
10 hundred and sixty (\$36,260.00) dollars.

For general expenses, namely, all other materials, sup-2 plies and expenses incident to maintenance of the institu-3 tion and the patients thereof, whether present or absent, for 4 the year nineteen hundred seventeen, the sum of sixty-one 5 thousand one hundred and ten (\$61,110.00) dollars, and for 6 the year nineteen hundred eighteen, the sum of sixty thou-7 sand four hundred and forty-two (\$60,442.00) dollars. For interest on Helen A. Gilman legacy, for the year nine-2 teen hundred seventeen, the sum of fifty (\$50.00) dollars, 3 and for the year nineteen hundred eighteen, the sum of 4 fifty (\$50.00) dollars.

For interest on the Joseph H. Williams legacy, for the 2 years nineteen hundred seventeen, the sum of forty (\$40.00) 3 dollars, and for the year nineteen hundred eighteen, the sum 4 of forty (\$40.00) dollars.

For interest on the Robie Amusement fund, for the year 2 nineteen hundred seventeen, the sum of one hundred and 3 forty (\$140.00) dollars, and for the year nineteen hundred 4 eighteen, the sum of one hundred and forty (\$140.00) dol-5 lars.

For new construction; psychopathic building designed and 2 equipped especially for the reception and treatment of new 3 cases with accommodations for two hundred patients, for 4 the year nineteen hundred seventeen, the sum of twenty-5 five thousand (\$25,000.00) dollars, and for the year nine-6 teen hundred eighteen, the sum of seventy-five thousand 7 (\$75,000.00) dollars.

For the Bangor State Hospital:

For personal services, namely, for salaries and wages of 2 all officers and employees except those wholly engaged in 3 repairs of buildings and equipment, for the year nineteen 4 hundred seventeen, the sum of sixty-eight thousand six 5 hundred and forty-nine dollars and fifty-three (\$68,649.53) 6 cents, and for the year nineteen hundred eighteen, the sum

7 of sixty-eight thousand eight hundred and forty-nine dol-8 lars and fifty-three (\$69,849.53) cents.

For food supplies, namely, all articles of food, for the year 2 nineteen hundred seventeen, the sum of sixty-eight thousand 3 and twenty-two dollars and eighty-one (\$68,022.81) cents, 4 and for the year nineteen hundred eighteen, the sum of 5 sixty-eight thousand and twenty-two dollars and eighty-one 6 (68,022.81) cents.

For clothing, namely, all articles of personal clothing and 2 materials for making the same, for the year nineteen hun-3 dred seventeen, the sum of three thousand six hundred and 4 nineteen dollars and twenty-seven (\$3,619.27) cents, and for 5 the year nineteen hundred eighteen, the sum of three thou-6 sand six hundred and nineteen dollars and twenty-seven 7 (\$3,619.27) cents.

For repairs and equipment, namely, all materials and sup-2 plies required for upkeep of grounds, buildings and attached 3 fixtures; all additions to and repairs and replacements of 4 furniture and equipment, including farm equipment and live-5 stock, and all personal services rendered wholly in connec-6 tion with repair work, for the year nineteen hundred seven-7 teen, the sum of twenty-three thousand (\$23,000.00) dol-8 lars, and for the year nineteen hundred eighteen, the sum 9 of twenty-three thousand (\$23,000) dollars.

For general expenses, namely, all other materials, supplies 2 and expenses incident to maintenance of the institution and 3 the patients thereof, whether present or absent, for the year 4 nineteen hundred seventeen, the sum of forty-three thou-5 sand and eight dollars and thirty-nine (\$43,008.39) cents, 6 and for the year nineteen hundred and eighteen, the sum 7 of forty-three thousand and eight dollars and thirty-nine 8 \$43,008.39) cents.

For interest on the Robie Amusement fund, for the year 2 nineteen hundred seventeen, the sum of one hundred and 3 forty (\$140.00) dollars, and for the year nineteen hundred 4 eighteen, the sum of one hundred and forty (\$140.00) dol5 lars.

For changing over heating system, for the year nineteen 2 hundred seventeen, the sum of six thousand (\$6,000.00) 3 dollars.

For sleeping rooms, night nurses, for the year nineteen 2 hundred seventeen, the sum of two thousand five hundred 3 (\$2,500.00) dollars.

Provided, that any balance of the sums above appropriated 2 for the year nineteen hundred seventeen which may remain 3 unexpended at the end of the year shall be available for 4 expenditure during the year nineteen hundred eighteen, and 5 provided further, that the governor and council may, by 6 order, upon recommendation of the trustees of the said in 7 stitutions, authorize the use of unexpended balances of any 8 of the above appropriations to meet deficiencies in other 9 appropriations for the same institution.
