STATE OF MAINE

IN THE YEAR OF OUR LORD ONE THOUSAND NINE HUNDRED AND SEVENTEEN

RESOLVE, in favor of the State Juvenile Institutions for maintenance and other purposes for the years nineteen hundred seventeen and nineteen hundred eighteen.

Resolved: That there be, and hereby is, appropriated.

FOR THE STATE SCHOOL FOR BOYS

For personal services, namely, for salaries and wages of all 2 officers and employees except those wholly engaged in re-3 pairs of buildings and equipment, for the year nineteen hun-4 dred seventeen, the sum of fourteen thousand three hundred

5 and sixty-seven dollars and fourteen (\$14,367.14) cents, and 6 for the year nineteen hundred eighteen, the sum of fourteen 7 thousand three hundred and sixty-seven dollars and fourteen 8 (\$14,367.14) cents.

For food supplies, namely, all articles of food, for the year 2 nineteen hundred seventeen, the sum of fifteen thousand one 3 hundred and twenty-nine dollars and eighty-seven (\$15,-4 129.87) cents, and for the year nineteen hundred eighteen, 5 the sum of fifteen thousand one hundred and twenty-nine 6 dollars and eighty-seven (\$15,129.87) cents.

For clothing, namely, all articles of personal clothing and 2 materials for making the same, for the year nineteen hun-3 dred seventeen, the sum of two thousand seven hundred and 4 twenty dollars and eighty-four (\$2,720.84) cents, and for the 5 year nineteen hundred eighteen, the sum of two thousand 6 seven hundred and twenty dollars and eighty-four 7 (\$2,720.84) cents.

For repairs and equipment, namely, all materials and sup-2 plies required for upkeep of grounds, buildings and attached 3 fixtures; all additions to and repairs and replacements of 4 furniture and equipment, including farm equipment and live-5 stock, and all personal services rendered wholly in connec-6 tion with repair work, for the year nineteen hundred seven-7 teen, the sum of three thousand (\$3,000.00) dollars, and for 8 the year nineteen hundred eighteen, the sum of three thou-9 sand (\$3,000.00) dollars.

For general expenses, namely, all other materials, supplies

2 and expenses incident to maintenance of the institution and

- 3 the patients thereof, whether present or absent, for the year
- 4 nineteen hundred seventeen, the sum of twenty-four thou-
- 5 sand seven hundred and eighty-two dollars and fifteen
- 6 (\$24,782.15) cents, and for the year nineteen hundred
- 7 eighteen, the sum of twenty-four thousand seven hundred
- 8 and eighty-two dollars and fifteen (\$24,782.15) cents.

For interest on the Isaac Sanford legacy, for the year nine-

- 2 teen hundred seventeen, the sum of forty-two (\$42.00) dol-
- 3 lars, and for the year nineteen hundred eighteen, the sum of
- 4 forty-two (\$42.00) dollars.

FOR THE STATE SCHOOL FOR GIRLS

For personal services, namely, for salaries and wages of all

- 2 officers and employees except those wholly engaged in re-
- 3 pairs of buildings and equipment, for the year nineteen hun-
- 4 dred seventeen, the sum of nine thousand six hundred and
- 5 sixty-five (\$9,665.00) dollars, and for the year nineteen hun-
- 6 dred eighteen, the sum of ten thousand three hundred and
- 7 forty (\$10,340.00) dollars.

For food supplies, namely, all articles of food, for the year

- 2 nineteen hundred seventeen, the sum of twelve thousand
- 3 three hundred and thirty (\$12,330.00) dollars, and for the
- 4 year nineteen hundred and eighteen, the sum of thirteen
- 5 thousand one hundred and thirty (\$13,130.00) dollars.

For clothing, namely, all articles of personal clothing and

- 2 materials for making the same, for the year nineteen hun-
- 3 dred and seventeen, the sum of three thousand five hundred

4 (\$3,500.00) dollars, and for the year nineteen hundred 5 eighteen, the sum of three thousand seven hundred 6 (\$3,700.00) dollars.

For repairs and equipment, namely, all materials and sup2 plies required for upkeep of grounds, buildings and attached
3 fixtures; all additions to and repairs and replacements of
4 furniture and equipment, including farm equipment and live5 stock, and all personal services rendered wholly in connec6 tion with repair work, for the year nineteen hundred and
7 seventeen, the sum of three thousand nine hundred
8 (\$3,900.00) dollars, and for the year nineteen hundred
9 eighteen, the sum of three thousand three hundred and
10 twenty-five (\$3,325.00) dollars.

For general expenses, namely, all other materials, supplies 2 and expenses incident to maintenance of the institution and 3 the inmates thereof, whether present or absent, for the year 4 nineteen hundred and seventeen, the sum of eight thousand 5 nine hundred and forty-five dollars and ninety-six 6 (\$8,945.96) cents, and for the year nineteen hundred and 7 eighteen, the sum of seven thousand eight hundred and 8 forty-five dollars and ninety-six (\$7,845.96) cents.

For interest on the Nellie F. Shaw trust fund, for the year 2 nineteen hundred and seventeen, the sum of two hundred 3 and thirty-seven dollars and fifty (\$237.50) cents, and for 4 the year nineteen hundred eighteen, the sum of two hundred 5 and thirty-seven dollars and fifty (\$237.50) cents.

For interest on the Eliza Mustard trust fund, for the year

2 nineteen hundred and seventeen, the sum of one hundred and

- 3 ninety-five dollars and sixty-three (\$195.63) cents, and for
- 4 the year nineteen hundred and eighteen, the sum of one hun-
- 5 dred and ninety-five dollars and sixty-three (\$195.63) cents.

For interest on the Peter Lane fund, for the year nineteen

- 2 hundred and seventeen, the sum of fifty-seven dollars and
- 3 eighty-three (\$57.83) cents, and for the year nineteen hun-
- 4 dred and eighteen, the sum of fifty-seven dollars and eighty-
- 5 three (\$57.83) cents.

For interest on the Augustus Hopkins trust fund, for the

- 2 year nineteen hundred and seventeen, the sum of fifty
- 3 (\$50.00) dollars, and for the year nineteen hundred and
- 4 eighteen, the sum of fifty (\$50.00) dollars.

For construction of new water system, for the year nine-

- 2 teen hundred and seventeen, the sum of two thousand
- 3 (\$2,000.00) dollars.

For construction of new central building, for the year nine-

- 2 teen hundred and seventeen, the sum of twenty thousand
- 3 (\$20,000.00) dollars, and for the year nineteen hundred and
- 4 eighteen, the sum of forty thousand (\$40,000.00) dollars.

Provided, that any balance of the sums above appropriated

- 2 for the year nineteen hundred and seventeen which may re-
- 3 main unexpended at the end of the year shall be available for
- 4 expenditure during the year nineteen hundred and eighteen,
- 5 and provided further, that the Governor and Council may,
- 6 by order, upon recommendation of the trustees of the said
- 7 institutions, authorize the use of unexpended balances of any

- 8 of the above appropriations to meet deficiencies in other ap-
- 9 propriations for the same institution.
