AN ACT to amend Section forty-five of Chapter one hundred and seventeen of the Revised Statutes, relating to the amounts to be paid for clerk hire in the county offices.

---

*Be it enacted by the People of the State of Maine, as follows:*

Section forty-five of chapter one hundred and seventeen  
2 of the revised statutes, is hereby amended by striking out  
3 in the thirteenth paragraph of said section the words, "Sag-  
4 adahoc county; for clerks in the office of register of deeds,  
5 three hundred twenty-five dollars; for clerks in the office  
6 of register of probate, three hundred twenty-five dollars;

7 for clerks in the office of clerk of courts, four hundred dol-  
8 lars,” and inserting in place thereof the following: ‘Saga-  
9 dahoc county; for clerks in the office of the register of deeds,  
10 four hundred dollars; for clerks in the office of register of  
11 probate, four hundred dollars; for clerks in the office of  
12 clerk of courts, four hundred dollars,’ so that said section,  
13 as amended, shall read as follows:

‘Sect. 45. The several county treasurers shall pay week-  
2 ly to the clerks employed by the several officials in their re-  
3 spective counties, the wages to which they may be entitled  
4 and shall take individual receipts therefor. County officials  
5 for whom provision for clerk hire may be made, shall cer-  
6 tify to the county treasurer the names of their clerks and  
7 the weekly wages at which they may be employed. Clerks  
8 shall be allowed a vacation not to exceed two weeks in any  
9 one year without loss of pay. The total sums to be paid  
10 annually to such clerks as wages shall not exceed the fol-  
11 lowing:

In Androscoggin county; for clerks in the office of regis-  
2 ter of deeds, five hundred twenty dollars; for clerks in the  
3 office of register of probate, five hundred twenty dollars; for  
4 clerks in the office of clerk of courts, six hundred dollars.

In Aroostook county; for clerks in the office of register of  
2 deeds, of the northern district, five hundred dollars; for  
3 clerks in the office of register of deeds of the southern dis-  
4 trict, one thousand five hundred dollars; for clerks in the  
5 office of register of probate, six hundred twenty-four dol-

6 lars; for clerks in the office of clerk of courts, one thou-  
7 sand six hundred dollars.

Cumberland county; for clerks in the office of register of  
2 deeds, two thousand seven hundred dollars; for clerks in  
3 the office of register of probate, two thousand one hundred  
4 dollars; for clerks in the office of clerk of courts, two thou-  
5 sand two hundred dollars; for clerks in the office of the re-  
6 corder of Portland municipal court, seven hundred and  
7 eighty dollars.

Franklin county; for clerks in the office of register of deeds,  
2 three hundred dollars; for clerks in the office of register  
3 of probate, two hundred dollars; for clerks in the office of  
4 clerk of courts, three hundred dollars.

Hancock county; for clerks in the office of register of  
2 deeds, one thousand five hundred dollars; for clerks in the  
3 office of register of probate, five hundred twenty dollars;  
4 for clerks in the office of clerk of courts, six hundred dol-  
5 lars.

Kennebec county; for clerks in the office of register of  
2 deeds, one thousand seven hundred dollars; for clerks in  
3 the office of register of probate, six hundred dollars; for  
4 clerks in the office of clerk of courts, one thousand three  
5 hundred dollars.

Knox county; for clerks in the office of register of deeds,  
2 two hundred fifty dollars; for clerks in the office of reg-  
3 ister of probate, two hundred fifty dollars; for clerks in  
4 the office of clerk of courts, three hundred dollars.

Lincoln county; for clerks in the office of register of deeds,  
2 two hundred dollars; for clerks in the office of register of  
3 probate, one hundred sixty dollars; for clerks in the office of  
4 clerk of courts, one hundred dollars.

Oxford county; for clerks in the office of register of  
2 deeds, six hundred dollars; for clerks in the office of reg-  
3 ister of probate, two hundred dollars; for clerks in the of-  
4 fice of clerk of courts, two hundred dollars.

Penobscot county; for clerks in the office of register of  
2 deeds, one thousand eight hundred dollars; for clerks in the  
3 office of register of probate, one thousand two hundred dol-  
4 lars; for clerks in the office of clerk of courts, one thousand  
5 two hundred dollars.

Piscataquis county; for clerks in the office of register of  
2 deeds, five hundred dollars; for clerks in the office of reg-  
3 ister of probate, two hundred dollars; for clerks in the of-  
4 fice of clerk of courts, five hundred dollars.

Sagadahoc county; for clerks in the office of register of  
2 deeds, four hundred dollars; for clerks in the office of pro-  
3 bate, four hundred dollars; for clerks in the office of clerk  
4 of courts, four hundred dollars.

Somerset county; for clerks in the office of register of  
2 deeds, five hundred dollars; for clerks in the office of reg-  
3 ister of probate, one hundred fifty dollars; for clerks in  
4 the office of clerk of courts, six hundred dollars.

Waldo county; for clerks in the office of register of deeds,  
2 seven hundred eighty dollars; for clerks in the office of reg-

3 ister of probate, one hundred dollars; for clerks in the of-  
4 fice of clerk of courts, five hundred dollars.

Washington county; for clerks in the office of register of  
2 deeds, five hundred twenty dollars; for clerks in the office  
3 of register of probate, five hundred twenty dollars; for  
4 clerks in the office of clerk of courts, five hundred twenty  
5 dollars.

York county; for clerks in the office of register of deeds,  
2 one thousand six hundred dollars; for clerks in the office  
3 of register of probate, one thousand dollars; for clerks in  
4 the office of clerk of courts, seven hundred fifty dollars.'
