# IN THE YEAR OF OUR LORD ONE THOUSAND NINE HUNDRED AND SEVENTEEN

An Act to Amend Section One of Chapter Eighty-five of the Private and Special Laws of Nineteen Hundred Fifteen Entitled "An Act Establishing a Close Time on Lobsters in Certain Waters of Hancock County."

Be it enacted by the People of the State of Maine, as follows:
Section one of chapter eighty-five of the Private and Spec2 ial Laws of Nineteen Hundred Fifteen is hereby amended by
3 striking out after the word "the" in the sixth line of said
4 section, the words "eastern extremity of Naskeag Point in
5 the town of Brooklin and then running thence southeast

6 three-quarters east to the northwesterly point of Sheep Is-7 land; thence southerly along the westerly side of Sheep Is-8 land to its southern point; thence southeast one-quarter south 9 to the northeasterly point of Swan's Island; thence southeast 10 by the easterly side of Outer Long Island to a point three 11 nautical miles from Long Island Head," and inserting in 12 place thereof the following words, 'extreme southwestern 13 point of Mt. Desert Island known as Lopus' Point; thence 14 extending in a direct line to the extreme north line of Gott's 15 Island; thence following the easterly shore of Gott's Island 16 to the extreme southeast point of said island; thence in a di-17 rect line to the extreme north line of Great Duck Island; 18 thence following the western shore of Great Duck Island to 19 the lighthouse; thence in a direct southerly course three nau-20 tical miles,' so that said section as amended shall read as fol-21 lows:

'Sect. I. No person shall take, catch, kill or destroy any 2 lobsters between the first day of July and the first day of 3 September in each year in any of the waters of Hancock 4 County, between a line on the east-extending due north and 5 south through Egg Rock Light in Frenchman's Bay and a 6 line on the west and south, beginning at the extreme south-7 western point of Mt. Desert island known as Lopus' Point; 8 thence extending in a direct line to the extreme north end of 9 Gott's Island; thence following the easterly shore of Gott's 10 Island to the extreme southeast point of said island; thence 11 in a direct line to the extreme north end of Great Duck Is12 land; thence following the western shore of Great Duck 13 Island to the lighthouse; thence in a direct southerly course 14 three nautical miles; thence due east to the line extending 15 south from Egg Rock Light; and no person shall set a trap 16 within said waters for the purpose of taking, catching, kill-17 ing or destroying any lobsters between said dates, under a 18 penalty of one dollar for each lobster so taken, caught, killed 19 or destroyed and under a penalty of five dollars for each 20 lobster trap so set for said purpose.'
