STATE OF MAINE

IN THE YEAR OF OUR LORD ONE THOUSAND NINE HUNDRED AND NINETEEN

AN ACT to amend section twenty-five of chapter 18 of the Revised Statutes.

Be it enacted by the People of the State of Maine, as follows:
Section 25 of chapter 18 of the Revised Statutes is hereby
2 amended by inserting in the thirteenth line thereof after the
3 word "fills" the following:

'All said appointments shall be made in the following man-2 ner: The Maine Dental Society may at its annual meeting 3 each year nominate six (6) members of said society who 4 fulfill all the foregoing requirements, whose names shall be 5 forthwith certified to the governor by the president and the 6 secretary of said society, and if said list is so submitted in

7 any year the governor shall, until the date of the next an-8 nual meeting of said society, appoint as dental examiners 9 only those men whose names appear on said list. In case 10 of the failure in any year of the Maine Dental Society to 11 nominate candidates as aforesaid, the governor shall, until 12 the date of the next annual meeting of said society, make said 13 appointments from the members of said society in good 14 standing.' So that said section, as amended, shall read as 15 follows:

'Sect. 25. Appointment of Board of Dental Examiners; 2 vacancies; removal. 1913, chapter 53. sections 2, 3, 4. The 3 governor with the advice and consent of the council, shall 4 appoint a board of dental examiners, consisting of five mem-5 bers of the dental profession, who shall be graduates of a re-6 putable dental college, and who shall have been in the actual 7 practice of dentistry in this state for at least five years im-8 mediately preceding the appointment. One member shall be 9 appointed annually, as the terms of the present members ex-10 pire, to hold office for five years from the first day of Jan-11 uary. After five years from the thirteenth day of March, 12 nineteen hundred and thirteen, no person shall be eligible 13 to appointment on said board who shall have served ten 14 years or more on a dental examining board in this state. 15 Any vacancy in said board shall be filled by the appointment 16 of a person qualified as aforesaid, to hold office during the 17 unexpired term of the member whose place he fills. All 18 said appointments shall be made in the following manner:

19 The Maine Dental Society may at its annual meeting each 20 year nominate six (6) members of said society who fulfill 21 all the foregoing requirements, whose names shall be forth-22 with certified to the governor by the president and the sec-23 retary of said society, and if said list is so submitted in any 24 year the governor shall, until the date of the next annual 25 meeting of said society, appoint as dental examiners only 26 those men whose names appear on said list. In case of the 27 failure in any year of the Maine Dental Society to nominate 28 candidates as aforesaid, the governor shall, until the date of 20 the next annual meeting of said society, make said appoint-30 ments from the members of said society in good standing. 31 The governor, with the advice and consent of the council, 32 may remove any member of said board on proven charges 33 of inefficiency, incompetence, immorality or unprofessional 34 conduct.'
