STATE OF MAINE

IN THE YEAR OF OUR LORD ONE THOUSAND
NINE HUNDRED AND NINETEEN

RESOLVE, Providing for the Compilation, Printing and
Distribution of an Index to the Private and Special Laws
and to the Resolves of the State of Maine.

Resolved, That the state librarian be and hereby is au-
2 thorized and empowered to make an index to the private
3 and special laws of the state of Maine and to the resolves
4 of the state of Maine from the incorporation of the state
5 to the year nineteen hundred and nineteen, inclusive, to
6 employ such assistance in the making of said index as
7 he may deem necessary, and to make a contract for the
8 printing and publishing of not less than one thousand copies
9 of such index; and that the sum of five thousand dollars

to be and is hereby appropriated for the above purposes.

Resolved, That the copies of the index printed under this
2 resolve shall be deposited in the office of the state libra-
3 rian, who shall distribute the same as follows: one copy
4 to the governor and to each member of the executive coun-
5 cil, one copy to each former governor of the state, one
6 copy to each of the justices of the supreme judicial and
7 superior courts and to the reporter of decisions, one copy
8 to each former justice of the supreme judicial court, one
9 copy to the judge of the circuit court of appeals of the
10 United States residing in the district of Maine, one copy
11 to the judge of the district court of the United States for
12 the district of Maine, one copy to the secretary of state,
13 one copy to the attorney general, one copy to each county
14 attorney, one copy to each judge of probate, one copy to
15 each college and theological institution, two copies to the
16 University of Maine Law School, one copy to the Maine
17 Historical Society, one copy to each county law library,
18 one copy to each senator and representative of the state
19 in Congress, one copy to the library of each state or terri-
20 tory of the United States, two copies to the library of
21 Congress, ten copies to the librarian of the Maine state
22 library for the use of the library; the remainder of said
23 copies to be sold at a price to be fixed by the state librarian
24 and the proceeds thereof to be added to the maintenance
25 appropriation of the Maine state library. The several per-
26 sons in this state furnished with the index as aforesaid

27 shall be responsible for the same and shall deliver it to
28 their successors in office, to be continually kept for the use
29 of the office, and the copies so furnished for the use of
30 such offices shall be marked as provided by section twenty-
31 seven of chapter three of the revised statutes, and shall
32 have a registered number conforming to the list to be kept
33 by the librarian of the Maine state library.
