## IN THE YEAR OF OUR LORD ONE THOUSAND NINE HUNDRED AND NINETEEN

AN ACT Repealing Chapter One Hundred Eighty-one of the Private and Special Laws of Nineteen Hundred Eleven, Chapter One Hundred Thirty-five of the Private and Special Laws of Nineteen Hundred Thirteen, Chapters One Hundred Fifty-six and One Hundred Seventy-eight of the Private and Special Laws of Nineteen Hundred Fifteen, Chapter Seventy-five of the Private and Special Laws of Nineteen Hundred Seventy-eight of Nineteen Hundred Seventy-eight of Cumberland the County Commissioners of the County of Cumberland the Right to Sell or Lease Certain Property.

Be it enacted by the People of the State of Maine, as follows: Section 1. That chapter one hundred eighty-one of the 2 private and special laws of nineteen hundred eleven, chap-3 ter one hundred thirty-five of the private and special laws 4 of nineteen hundred thirteen, chapters one hundred fifty-5 six and one hundred seventy-eight of the private and spe-6 cial laws of nineteen hundred fifteen, chapter seventy-five 7 of the private and special laws of nineteen hundred seven-8 teen, be repealed.

Sect. 2. The county commissioners of the county of 2 Cumberland are hereby authorized to bargain, sell, convey, 3 lease, let, transfer, assign or otherwise, dispose of all the 4 property, real, personal and mixed and all rights and prop-5 erty, rights in contracts and other choses in action acquired 6 or held by virtue of any of the before mentioned acts hereby 7 repealed, and for the purpose aforesaid to make, execute 8 and deliver good and sufficient deeds, leases, bills of sale, 9 assignments or other instruments necessary or convenient 10 to carry the purposes of this act into effect, and all sums II of money arising therefrom shall be paid to the county 12 treasurer of the county of Cumberland, who shall place 13 the same to the credit of a sinking fund to be applied to 14 the purchase and payment of the principal and interest of 15 any indebtedness created by authority of any of the fore-16 going acts hereby repealed and the balance of said sinking 17 fund after payment of all said debts shall be applied to gen-18 eral county purposes.
