#### STATE OF MAINE

## IN THE YEAR OF OUR LORD ONE THOUSAND NINE HUNDRED AND NINETEEN

AN ACT to Amend Section One Hundred Thirty-seven of Chapter Sixteen of the Revised Statutes Relating to the Maintaining of Evening Schools, and to Provide for Americanization and the Reducing of Illiteracy.

Be it enacted by the People of the State of Maine, as follows:

Section one hundred thirty-seven of chapter sixteen of the

- 2 revised statutes is hereby amended by adding to said section
- 3 the following words 'provided, however, that for the purpose
- 4 of Americanization and also for the purpose of reducing il-
- 5 literacy within the state all towns and cities in which there
- 6 are persons of normal mentality over eighteen years of age

7 who are unable to read, to write and to speak the English 8 language to a reasonable degree of efficiency, or who are 9 unable to read and to write in any language, are hereby 10 authorized to organize and conduct evening schools or II classes in which such persons of foreign birth or foreign ex-12 traction shall be given opportunity to learn to read, to write 13 and to speak the English language and to learn the duties of 14 citizens in a democracy, and also in which illiterates shall be 15 given opportunity to learn to read and to write and to pur-16 sue such other subjects as will increase their civic intelli-17 gence. Such schools and classes shall meet the approval of 18 the state superintendent of schools in regard to the qualifica-19 tions of instructors, length of term and subjects offered and 20 towns maintaining them shall be reimbursed to the same 21 extent and in the same manner as for other schools and 22 classes set forth in this section,' so that said section when 23 amended shall read as follows:

'Sect. 37. Whenever the superintending school committee 2 of any town shall have maintained during the school year an 3 evening school as provided by section twenty-five, said town 4 shall be reimbursed by the state a sum equal to two-thirds the 5 amount paid for instruction in such evening school, provided 6 there shall have been offered, in addition to the subjects else-7 where prescribed for evening schools, courses in the com-8 mercial branches, the domestic and manual arts or the 9 elements of the trades, said courses to be subject to the ap-10 proval of the state superintendent of public schools; no town

II shall be entitled to receive a reimbursement under the pro-12 visions of this section, unless the total average attendance in 13 said courses shall equal not less than twenty-five per cent of 14 the average attendance of the school; provided, however, that 15 for the purpose of Americanization and also for the purpose 16 of reducing illiteracy within the state all towns and cities in 17 which there are persons of normal mentality over eighteen 18 years of age who are unable to read, to write and to speak the 10 English language to a reasonable degree of efficiency, or who 20 are unable to read and to write in any language, are hereby 21 authorized to organize and conduct evening schools or classes 22 in which such persons of foreign birth or foreign extraction 23 shall be given opportunity to learn to read, to write and to 24 speak the English language and to learn the duties of citizens 25 in a democracy, and also in which illiterates shall be given 26 opportunity to learn to read and to write and to pursue such 27 other subjects as will increase their civic intelligence. 28 schools and classes shall meet the approval of the state super-29 intendent of schools in regard to the qualifications of instruc-30 tors, length of term and subjects offered and towns main-31 taining them shall be reimbursed to the same extent and in 32 the same manner as for other schools and classes set forth 33 in this section.
