HOUSE AMENDMENT A TO SENATE AMENDMENT

“A” TO RESOLVE, Authorizing the Governor and Council to Pay All Outstanding Bills for Material Furnished and Labor in the Construction of Steven’s Cottage at Skowhegan for the Reformatory for Women, Being House Document No. 418.

House Document No. 418, entitled a Resolve, authorizing
2 the governor and council to pay all outstanding bills for
3 material furnished and labor in the construction of Steven’s
4 cottage at Skowhegan for the reformatory for women, as
5 amended by Senate amendment A is hereby further amend-
6 ed as follows:

Insert after the word "materials" and before the word
2 "furnished" in the fourth line, and after the word "ma-
3 terial" and before the word "furnished" in the eleventh and
4 twelfth lines, the following words, 'or for money advanced
5 for the payment of any labor performed or for the pur-
6 chase of any materials'. So that said resolve as now
7 amended shall read as follows:

'The treasurer of state shall honor and pay any orders
2 or assignments made by George H. Wilbur & Son to any
3 person, firm or corporation for the purpose of paying for
4 any labor or materials or for money advanced for the pay-
5 ment of any labor performed or for the purchase of any
6 materials furnished for the construction of the woman's
7 reformatory to the extent of the money now in the hands
8 of the treasurer due and owing George H. Wilbur & Son
9 on account of such construction. And upon warrant of
10 the governor and council, the treasurer of state shall pay
11 from the state contingent fund the amount of the claim
12 of any person, firm or corporation for labor or material
13 or for money advanced for the payment of any labor per-
14 formed or for the purchase of any materials furnished and
15 used in the construction of the woman's reformatory for
16 which no order has been made and for which George H.
17 Wilbur & Son is liable but has failed to pay by reason of
18 bankruptcy or otherwise is unable to pay. And there is
19 hereby appropriated from the state contingent fund a suffi-
20 cient sum to meet the foregoing provisions.'
