STATE OF MAINE

IN THE YEAR OF OUR LORD ONE THOUSAND
NINE HUNDRED AND NINETEEN

AN ACT to Amend Chapter One Hundred and Sixty-six of the Private and Special Laws of Nineteen Hundred and Eleven, as Amended by Chapter One Hundred and Eighty-nine of the Private and Special Laws of Nineteen Hundred and Fifteen, Relating to the Piscataquis Municipal Court; Making the Clerk of Courts of Piscataquis County Recorder of Said Municipal Court and Fixing the Salary of Said Recorder.

Be it enacted by the People of the State of Maine, as follows:

Section 1. Section five of chapter one hundred and sixty-
2 six of the private and special laws of nineteen hundred and

3 eleven is hereby amended by striking out all of said section
4 five and substituting therefor the words :

‘Sect. 5. The clerk of courts of Piscataquis county shall
2 be ex-officio recorder of said Piscataquis municipal court
3 and he shall keep the records of said court when requested
4 so to do by said judge ; and in case of absence of said
5 judge from the court room, or when the office of said judge
6 shall be vacant, the said recorder shall have and exercise
7 all the powers of the judge and perform all the duties re-
8 quired of said judge by this act, and shall be empowered
9 to sign and issue all papers and processes, and do all acts
10 as fully and with the same effect as the judge could do if
11 he were acting in the premises, excepting the trial of ac-
12 tions in civil cases ; and the signature of said recorder, as
13 such, shall be sufficient evidence of his rights to act instead
14 of the judge. Said recorder shall be paid for all services
15 as recorder of said Piscataquis municipal court an annual
16 salary of three hundred dollars in quarterly payments on
17 the first days of January, April, July and October of each
18 year from the county treasury of Piscataquis county.’

Sect. 2. So much of chapter one hundred and eighty-
2 nine of the private and special laws of nineteen hundred and
3 fifteen, as is inconsistent with this act, is hereby repealed.
