STATE OF MAINE

IN THE YEAR OF OUR LORD ONE THOUSAND NINE HUNDRED AND NINETEEN

AN ACT to Amend Section Three of Chapter Three Hundred Forty-six of the Private and Special Laws of Nineteen Hundred and Five as Amended by Chapter Twenty-seven of the Private and Special Laws of Nineteen Hundred and Fifteen Providing for and Fixing the Salaries of the Probation Officer and the Assistant Probation Officer for the County of Cumberland.

Be it enacted by the People of the State of Maine, as follows:

Section three of chapter three hundred and forty-six of

- 2 the private and special laws of nineteen hundred five as
- 3 amended by chapter twenty-seven of the private and special
- 4 laws of nineteen hundred fifteen is hereby amended by strik-

5 ing out the words "seven hundred and fifty" in the sixth 6 line thereof, and inserting in place the words 'nine hun-7 dred,' so that said section as amended shall read as fol-8 lows:

'Sect. 3. The salary of said probation officer shall be 2 twelve hundred dollars per year, payable monthly in equal 3 installments by the county treasurer of the county of Cum-4 berland, upon warrants drawn by the county commissioners 5 of said county. The salary of said assistant probation officer shall be nine hundred dollars per year, payable monthly 7 in equal installments by the county treasurer under the 8 same conditions as is provided for the payment of the sal-9 ary of the probation officer.

When a person has been placed on probation the court 2 may direct and authorize the probation officer to expend 3 for the temporary support of such person, or for his trans-4 portation, or for both such purposes such reasonable sum 5 as the court shall consider expedient and any sums so ex-6 pended, together with actual disbursements for necessary 7 expenses made by said probation officer while in the per-8 formance of his duty, shall be reimbursed to him out of 9 the county treasury of the county of Cumberland after ap-10 proval by the recorder of said municipal court, when said 11 expenditure was made by order of the judge of said court, 12 or, in his absence, the recorder, or when said duties were 13 performed on account of said municipal court, and by the 14 clerk of said superior court when the expenditure was made

15 by order of the said superior court, provided that said offi-16 cer shall not be allowed in all for such disbursements ex-17 clusive of said expenditures made by special order of said 18 courts, a greater sum than three hundred dollars in any 19 one year.'
