STATE OF MAINE

IN THE YEAR OF OUR LORD ONE THOUSAND NINE HUNDRED AND NINETEEN

AN ACT to authorize the county of Androscoggin to enlarge and repair the county buildings at Auburn in said county and erect a new building, and to enlarge and construct safety vaults.

Be it enacted by the People of the State of Maine, as follows:

Section 1. EXPENDITURE OF \$125,000 AUTHOR-

- 2 IZED FOR REPAIRING AND CONSTRUCTING A
- 3 NEW BUILDING APPURTENANT TO THE COUNTY
- 4 BUILDINGS AND RECONSTRUCTING AND BUILD-
- 5 ING NEW SAFETY VAULTS:

The county of Androscoggin is hereby authorized and em-2 powered to expend so much money as shall be necessary, 3 not to exceed in all, the sum of one hundred and twenty4 five thousand dollars, in altering, enlarging and repairing
5 of the county buildings at Auburn in said county and in
6 constructing a new building appurtenant thereto and to be
7 used by said county and dedicated to its business in said
8 Auburn, and enlarging, remodeling and re-building or
9 building new vaults for the records of the Clerk of Courts,
10 the Register of Deeds and the Register of probate and the
11 County Commissioners in said county, so as to better pre12 serve the records of said offices and render them more con13 venient for use.

Sect. 2. LOAN AUTHORIZED:

For the purpose of raising the money necessary to carry 2 out the provisions of this act, said county is hereby author-3 ized and empowered and it shall be the duty of the county 4 commissioners acting for and in behalf of said county, 5 whenever requested to do so by the commission created by 6 section 3 of this act, to make a loan or loans and to cause 7 notes, bonds or other obligations of said county with cou-8 pons for interest at a rate not to exceed six per cent. (6%) 9 to be issued, payable at regular periods not exceeding thirty 10 (30) years from the date of issuance. Said commission 11 hereby created shall determine the amount, not exceeding 12 \$125,000, time of payment, rate of interest, not exceeding 13 6%, and the form of said notes, bonds or other obligations 14 and shall issue the same from time to time as the money 15 is needed to pay for the work done under this act.

Sect. 3. COMMISSION CREATED WITH FULL POW-2 ERS TO MAKE AND PROCURE PLANS AND SUPER-3 VISE WORK:

John A. Morrill and George C. Wing of Auburn and George 2 Pottle and Harry J. Parker of Lewiston and Clement S. 3 Stetson of Greene, all in said county and state, are hereby 4 constituted and appointed a commission to prepare and 5 procure plans and make contracts for the carrying out of 6 the provisions of this act. Said commission is hereby vest-7 ed with full power to determine the amount of money, not 8 exceeding said sum of \$125,000, to be spent in altering, re-9 pairing and enlarging said county buildings and carrying 10 out all the other provisions of section I of this act and to 11 determine the kind and extent of repairs and extensions 12 and new construction if any, and shall have power to de-13 termine what amount of money, not exceeding \$125,000, 14 shall be spent in carrying out the provisions of this act and 15 shall have power to employ architects to assist in determin-16 ing the necessary repairs, extensions and improvements on 17 said county buildings or new buildings or construction ap-18 purtenant to said county buildings. Said commission shall 19 organize and appoint necessary officers, and may authorize 20 any member or members of the commission to act for the 21 commission in carrying out the provisions of this act. Said 22 commission shall have the power to fill vacancies existing 23 in the same for any cause and shall serve without pay, but 24 all necessary expenses of said commission in carrying out 25 the provisions of this act shall be paid out of the moneys 26 raised under this act.
