STATE OF MAINE

IN THE YEAR OF OUR LORD ONE THOUSAND NINE HUNDRED AND NINETEEN

AN ACT to amend section one of chapter fifty-five of the Revised Statutes of Maine, relating to Causes Determined by the Public Utilities Commission.

Be it enacted by the People of the State of Maine, as follows:

Section one of chapter 55 of the revised statutes is hereby 2 amended by inserting in the fourteenth line of said section 3 after the word "report", the words 'which report shall be 4 printed each year and shall contain such matter as the com-5 mission determines is of public interest. There shall also 6 each year be printed, either in its report or in a separate 7 volume, such of the decisions and orders of the commission

8 as it determines are of public interest.' So that said section 9 as amended shall read as follows:

'Section 1. The public utilities commission as heretofore 2 established, shall consist of three members appointed by the 3 governor, with the advice and consent of the council, from 4 time to time upon the expiration of the terms of the several 5 members, for terms of seven years; any vacancy occurring 6 in said commission shall be filled by appointment for the 7 unexpired portion of the term in which such vacancy occurs. 8 One member of the commission shall be designated by the 9 governor as chairman. The commission shall adopt and 10 have a seal and be provided with an office at the state house II in which its records shall be kept. Under the direction of 12 the governor and council the commission may expend such 13 sums of money as may be necessary for the purchase of 14 books, maps, stationery, office furniture and supplies, for 15 procuring statistics and information and for defraying ex-16 penses incidental to the discharge of its duties; a statement 17 of such expenses shall accompany its annual report, which 18 report shall be printed each year and shall contain such 19 matter as the commission determines is of public interest. 20 There shall also each year be printed, either in its report or 21 in a separate volume, such of the decisions and orders of the 22 commission as it determines are of public interest. The 23 commission shall appoint a clerk and an assistant clerk, also 24 a chief inspector of utilities, who shall be a practical railroad 25 man and shall perform such duties as the commission may 26 require. The clerk shall keep a full and minute record of 27 the proceedings of the commission which shall be open to 28 public inspection at all times. The assistant clerk shall 29 assist the clerk in the performance of his duties, and in the 30 absence of the clerk shall have the same powers as the 31 clerk. The commission shall have custody and control of 32 all records, maps and papers pertaining to the offices of the 33 former board of railroad commissioners and the former state 34 water storage commission.'
