Tabulations to Show Relative Amounts Apportionable from State School Funds for the Support of Common Schools by Various Methods Involving Aggregate Attendance in Common Schools

The following tabulations have been prepared in the State Department of Education by the request of the Committee on Education of the Seventy-ninth Legislature for the purpose of studying the relative effects of the element of aggregate attendance as a method for the distribution of all or a part of the State School Funds for the support of common schools in connection with the consideration of the bill entitled "An Act to Provide for the Distribution of State School Funds Available for the Support of Common Schools" (House Doc. No. 58). The amounts tabulated are the relative amounts that would have been distributable had any of the methods included in this report been used as a basis for the distribution of State Funds for the support of common schools during the year 1918. They are based upon the amounts available for the State support of common schools in 1918 and on figures of attendance for the school year 1917-18.

It should be noted that no attempt has been made to adjust the figures of aggregate attendance to meet special conditions which may have arisen under parallel circumstances to those provided for by section 3 of the proposed bill.

Attention is called to the explanatory notes on the following pages including the description of the funds and the headings of the tabulations.

EXPLANATORY NOTES

State Funds for the Support of Common Schools

The **State School Fund and School Mill Fund** (generally considered as one fund) for 1918 are made up as follows:

Both of these funds are distributed to the cities, towns and plantations of the State on the census basis (228,956 persons between the ages of 5 and 21 years, April 1, 1918).

The Common School Fund is made up from a tax of $1\frac{1}{2}$ mills on the State valuation and amounts to . . . \$782,104 40

One-third of the Common School Fund (\$260,701.47) is distributed to the cities, towns and plantations of the State on the census basis (same as State School Fund and School Mill Fund).

Two-thirds of the Common School Fund (\$521,402.93) is distributed to the cities, towns and plantations on the basis of their valuation as fixed by the State Assessors.

Amounts received by towns from the above funds are available only for common school purposes which are defined by law as follows: payment of teachers' wages and board, fuel, janitors' services, conveyance, tuition and board of pupils in common (elementary) schools only.

HEADINGS OF TABULATIONS

Col. 2. **Aggregate attendance in common schools** is the sum total of the number of days attendance for the school year 1917-18 of each regularly enrolled pupil in common (elementary) schools of the cities, towns and plantations of the State.

Col. 3. **Rate of taxation for the support of common schools** is determined by dividing the amounts raised by taxation by each city, town and plantation for the support of common schools (teachers' wages and board, fuel, janitors' services, conveyance, tuition and board of pupils in common schools) for the municipal year 1917-18 by the valuation of the city, town, or plantation as fixed by the State Assessors in 1916.

Col. 4. **Amount per pupil registered received by present method** of distribution of State school funds is determined by dividing the amounts received from the distribution of funds made in December, 1918, by the number of different pupils registered in the common (elementary) schools in the school year 1917-18.

Col. 5. **Present method—amount received from School Mill Fund and Common School Fund** includes the amounts distributed in December, 1918, out of both of the above funds—School Mill Fund on the basis of census and one-third of Common School Fund on basis of census and two-thirds on basis of valuation.

Col. 6. **A. Aggregate attendance for School Mill Fund and Common School Fund**—includes the relative amounts that would have been distributed if these funds both had been distributed on the basis of aggregate attendance in common schools.

Col. 7. **B. Aggregate attendance for School Mill Fund—census and valuation for Common School Fund**—includes the relative amounts that would have been distributed if the School Mill Fund (now distributed on census) had been distributed on the basis of aggregate attendance in common schools and the Common School Fund had been distributed as at present, one-third by census and two-thirds by valuation.

Col. 8. **C. Aggregate attendance for Common School Fund—census for School Mill Fund**—includes the relative amounts that would have been distributed if the Common School Fund (now distributed one-third on census and two-thirds on valuation) had been distributed on the basis of aggregate attendance in common schools and the School Mill Fund had been distributed as at present by census.

Col. 9. **D. Aggregate attendance for 2-3 Common School Fund—census for 1-3 Common School Fund and School Mill Fund**—includes the relative amounts that would have been distributed if one mill of the Common School Fund (now distributed on valuation) had been distributed on the basis of aggregate attendance in common schools and one-half mill of the Common School Fund and the School Mill Fund had been distributed as at present by census.

Col. 10. **E. Aggregate attendance for 1-3 Common School Fund and School Mill Fund—valuation for 2-3 Common School Fund**—includes the relative amounts that would have been distributed if one-half mill of the Common School Fund (now distributed on census) and the School Mill Fund (now distributed on census) had been distributed on the basis of aggregate attendance in common schools and one mill of the Common School Fund had been distributed as at present by valuation.
