STATE OF MAINE

IN THE YEAR OF OUR LORD ONE THOUSAND
NINE HUNDRED AND NINETEEN

RESOLVE, in Favor of the Bath Military and Naval Orphan Asylum: for Maintenance and Other Purposes for the Years Nineteen Hundred Nineteen and Nineteen Hundred Twenty.

Resolved: That there be, and hereby is, appropriated for
2 the Bath Military and Naval Orphan Asylum:

For personal services, namely, for salaries and wages of
2 all officers and employees except those wholly engaged in
3 repairs of buildings and equipment, for the year nineteen
3 hundred nineteen, the sum of seven thousand one hundred
5 (\$7,100) dollars, and for the year nineteen hundred twenty,
6 the sum of seven thousand one hundred (\$7,100) dollars.

For food supplies, namely, all articles of food, for the
2 year nineteen hundred nineteen, the sum of five thousand
3 six hundred twenty-five (\$5,625) dollars, and for the year
4 nineteen hundred twenty, the sum of five thousand six hun-
5 dred twenty-five (\$5,625) dollars.

For clothing, namely, all articles of personal clothing and
2 materials for making the same, for the year nineteen hun-
3 dred nineteen, the sum of one thousand seven hundred and
4 fifty (\$1,750) dollars, and for the year nineteen hundred
5 twenty, the sum of one thousand seven hundred and fifty
6 (\$1,750) dollars.

For repairs and equipment, namely, all materials and sup-
2 plies required for upkeep of grounds, buildings and at-
3 tached fixtures; all additions to and repairs and replace-
4 ments of furniture and equipment, including farm equip-
5 ment and live-stock, and all personal services rendered
6 wholly in connection with repair work, for the year nine-
7 teen hundred nineteen, the sum of six thousand four hun-
8 dred seventy-five (\$6,475) dollars, and for the year nine-
9 teen hundred twenty, the sum of one thousand (\$1,000)
10 dollars.

For general expenses, namely, all other materials, supplies
2 and expense incident to maintenance of the institution and
3 the inmates thereof, whether present or absent, for the year
4 nineteen hundred nineteen, the sum of three thousand five
5 hundred (\$3,500) dollars, and for the year nineteen hun-

6 dred twenty the sum of three thousand five hundred (\$3,500)
7 dollars.

Special appropriation, for the year nineteen hundred twen-
2 ty, the sum of five thousand (\$5,000) dollars for a new
3 recreation room or play house to be attached to the present
4 asylum and heated from the general heating plant.

Provided, that any balance of the sums above appropri-
2 ated for the year nineteen hundred nineteen which may
3 remain unexpended at the end of the year shall be available
4 for expenditure during the year nineteen hundred twenty,
5 and provided further, that the governor and council, may,
6 by order, upon recommendation of the trustees of said in-
7 stitution, authorize the use of unexpended balances of any
8 of the above appropriations to meet deficiencies in other
9 appropriations for such institution.
