STATE OF MAINE

IN THE YEAR OF OUR LORD ONE THOUSAND
NINE HUNDRED AND NINETEEN

RESOLVE, for Laying the County Taxes for the Year Nine-
teen Hundred and Nineteen.

WHEREAS, the appropriations called for in this resolve
are immediately necessary for the preservation of the public
health and safety, and in the opinion of this legislature con-
stitute an emergency as contemplated by the constitution, be it
therefore

Resolved: That the sum annexed to the counties in the
2 following schedule is hereby granted as a tax on each coun-
3 ty respectively to be appropriated, assessed, collected and
4 applied to the purpose of paying the debts and necessary
5 expenses of the same and for other purpose of law, for the
6 year nineteen hundred nineteen:

Penobscot, one hundred thousand five hundred and twenty dollars	100,520 00
Piscataquis, twenty-five thousand dollars	25,000 00
