STATE OF MAINE

IN THE YEAR OF OUR LORD ONE THOUSAND NINE HUNDRED AND NINETEEN

AN ACT Relating to the Appropriation for the Industrial Accident Commission.

Be it enacted by the People of the State of Maine, as follows:
Section twenty-nine of chapter fifty of the revised statutes *2* is hereby amended by striking out in the seventeenth and
3 eighteenth lines of said section the following words: "the
4 sum of two thousand dollars, or so much thereof as is neces5 sary," and by inserting in place thereof the words, 'a suffi6 cient amount'; also by striking out in the nineteenth and
7 twentieth lines the words, "the sum of seven thousand five

8 hundred dollars shall be annually appropriated," and by 9 inserting in place thereof the words, 'the legislature shall' 10 from time to time appropriate a sufficient amount'; so that 11 as amended said section shall read as follows:

'Sect. 29. Industrial Accident Commission of the State of 2 Maine; appointment of chairman; tenure; removal and ap-3 pointment of successor; appointment of secretary; appro-4 priation. Authority of commission. 1915, c. 295, sect. 29. 5 The industrial accident commission of the state of Maine 6 as heretofore established, shall consist of three members. 7 The insurance commissioner and the commissioner of labor 8 and industry shall be ex-officio members thereof. The gov-9 ernor shall appoint a chairman of the commission, who 10 shall be learned in the law and a member of the bar in good 11 standing; he shall hold office for three years from the date 12 of his appointment unless removed as hereinafter provided, 13 and until his successor is appointed and qualified; he shall 14 be sworn, and for inefficiency, wilful neglect of duty or for 15 malfeasance in office, may after notice and hearing be re-16 moved from office by the governor and council. In case of 17 vacancy occurring through death, resignation or removal, 18 the governor shall appoint a successor for the whole term 19 of three years, subject to removal as aforesaid. The com-20 mission shall have a secretary appointed and removable by 21 it. It shall be allowed a sufficient amount for expert and 22 clerical assistance and other expenses in organizing a suit-23 able system of administration. The legislature shall from 24 time to time appropriate a sufficient amount for the pay-25 ment of clerical and other assistance, physicians' and wit-26 ness fees, traveling and other expenses.

The commission shall have a seal bearing the words "In-2 dustrial Accident Commission of Maine." It shall have its 3 office and keep its records in the state house in Augusta, 4 but may hold sessions at any place within the state. The 5 commission shall have a general supervision over the ad-6 ministration of this act and shall have the following powers:

I. To make rules and regulations not inconsistent with 2 this act or other laws of the state for the purpose of carry-3 ing out the provisions hereof.

II. To issue subpoenas for witnesses and subpoenas duces2 tecum to compel the production of books and papers relat-3 ing to any questions in dispute before it.

III. The chairman of the commission at any hearing be-2 fore him under the provisions of this act, may issue sub-3 poenas for witnesses and subpoenas duces tecum to compel 4 the production of books and papers relating to any matters 5 in dispute before him. Witness fees in all proceedings un-6 der this act shall be the same as for witnesses before the 7 supreme judicial court.'
