SENATE AMENDMENT A to Senate Document Number 185.

Senate Document No. 185, entitled: "An Act to Amend 2 Section Sixteen of Chapter Nine of the Revised Statutes, 3 Relating to Inventory of Exempt Live Stock and Fowl," 4 is hereby amended by inserting after the word "Statutes" 5 in the title thereof the words 'as Amended by Chapter Two 6 Hundred and Eighty-five of the Public Laws of Nineteen 7 Hundred and Seventeen;' also by striking out everything 8 after the enacting clause and inserting therefor the follow-9 ing:

'Section sixteen of chapter nine of the revised statutes, 2 as amended by chapter two hundred and eighty-five of the

3 public laws of nineteen hundred and seventeen, is hereby 4 further amended by striking out in the second, third, fourth 5 and fifth lines of said section, as reprinted in the public 6 laws of nineteen hundred and seventeen, the words "the 7 number and value of all sheep in excess of the number of 8 thirty-five and swine in excess of the number of ten, year-9 ling and two year old neat cattle, stated separately, of 10 sheep and swine," and by inserting therefor, 'the number 11 and value of all neat cattle, eighteen months old and un-12 der, all sheep to the number of thirty-five and swine to 13 the number of ten, stated separately'; also by striking out 14 in the fifth and sixth lines of said section, as reprinted, the 15 word "thirteen" and substituting therefor the word 16 'eighteen'; also by striking out in the sixth, seventh and 17 eighth lines of said section, as reprinted, the words "and 18 of the eggs and poultry, stated separately, produced there-19 from during the year preceding," and by striking out the 20 comma after the word "fowl" in the sixth line and substi-21 tuting therefor a period, so that said section, as amended, 22 shall read as follows:

'Sect. 16. Assessors of taxes shall include in the inven-2 tory, required to be taken on April first, the number and 3 value of all neat cattle, eighteen months old and under, all 4 sheep to the number of thirty-five and swine to the num-5 ber of ten, stated separately, and at every fifth year after 6 nineteen hundred and eighteen the number and value of 7 each kind of domestic fowl. They shall make return there8 of to the state assessors who shall tabulate the returns and 9 publish them in detail. Said property shall not be included 10 in the tax list.'
