## STATE OF MAINE

## IN THE YEAR OF OUR LORD ONE THOUSAND NINE HUNDRED AND TWENTY-ONE

AN ACT to Amend Chapter Four Hundred and Sixty-five of the Private and Special Laws of Eighteen Hundred and Sixty-eight, Entitled, "An Act to Provide for the Election of a Superintending School Committee and a Superintendent of Schools in the City of Lewiston."

Be it enacted by the People of the State of Maine, as follows:

Section 1. Section one of chapter four hundred and sixty
interpretation of the private and special laws of eighteen hundred and

sixty-eight is hereby repealed and the following enacted in
stead thereof:

'Section 1. The superintending school committee of the 2 city of Lewiston shall consist of one member from each

3 ward elected as follows: At the annual municipal election 4 in nineteen hundred and twenty-two, the legal voters of each 5 ward, by separate ballot without party designation and con-6 taining only the names of the candidates for the superin-7 tending school committee, nominated by law as heretofore, 8 shall elect a member of the superintending school commit-9 tee, who shall serve for a term of years which shall be equal 10 to the number of the ward from which he shall be elected; II and annually thereafter, the wards, in rotation beginning 12 with ward one, shall elect one member to serve for a term 13 of years which shall be equal to the whole number of wards 14 in the city; each member shall be a resident of the ward 15 from which he shall be elected. Whenever, from any cause, 16 a vacancy shall occur in any ward, the city council shall 17 cause a special election to be held to fill, for the unexpired 18 term, such vacancy.'

Sect. 2. Section two of said chapter four hundred and 2 sixty-five of the private and special laws of eighteen hun-3 dred and sixty-eight is hereby amended by inserting after 4 the word "Lewiston" and before the word "may" in the 5 second line of said section the words, 'shall determine the 6 amount of money to be raised annually for the current ex-7 penditures of the common and high schools, which sum 8 shall be assessed, together with the sums for all other mu-9 nicipal purposes, and provided by the city council; and the 10 power to expend said sum shall be vested in said superintending school committee; and the city treasurer shall pay

12 all bills up to an amount not exceeding this sum, when 13 properly itemized and avouched by the said committee; and 14 the said superintending school committee of said city of 15 Lewiston', so that said section two as amended shall read 16 as follows:

'Sect. 2. The superintending school committee of said city 2 of Lewiston shall determine the amount of money to be 3 raised annually for the current expenditures of the com-4 mon and high schools, which sum shall be assessed, together 5 with the sums for all other municipal purposes, and pro-6 vided by the city council; and the power to expend said 7 sum shall be vested in said superintending school commit-8 tee; and the city treasurer shall pay all bills up to an amount o not exceeding this sum, when properly itemized and 10 avouched by the said committee; and the said superintending 11 school committee of said city of Lewiston may exercise all 12 the powers conferred, and shall discharge all the duties im-13 posed, by law, on superintending school committees and dis-14 trict school agents; and they may also appoint a superin-15 tendent of schools and truant officers, for such term and 16 with such compensation as the superintending school com-17 mittee of said city of Lewiston may determine. Such super-18 intendent may be removed at the pleasure of said commit-19 tee, and any vacancy shall be filled by their appointment.'
