## STATE OF MAINE

## IN THE YEAR OF OUR LORD ONE THOUSAND NINE HUNDRED AND TWENTY-ONE

AN ACT to Amend Section Ten, Chapter Twenty-five, of the Revised Statutes, as Amended by Section Three, Chapter Two Hundred and Fifty-eight, of the Public Laws of Nineteen Hundred and Seventeen, Providing for the Deposit of Surety Bonds or Certified Checks with Bids for State Highway Work.

Be it enacted by the Peop'e of the State of Maine, as follows:

Section ten of chapter twenty-five of the revised statutes,

- 2 as amended by section three of chapter two hundred and
- 3 fifty-eight of the public laws of nineteen hundred and seven-
- 4 teen, is hereby amended by inserting after the word "check"
- 5 in the twelfth line of said section as amended, the words

6 'or surety bond.' Said section is further amended by in7 serting after the word "checks," the first word in the fif8 teenth line, the words 'or surety bonds,' and said section
9 is further amended by inserting after the word "check."
10 the last word in the fifteenth line of said section as amended,
11 the words 'or bond,' so that said section as amended shall
12 read as follows:

'The commission shall have full power in the letting of 2 all contracts for the construction of all state and state-3 aid highways except as elsewhere herein otherwise pro-4 vided. The commission shall make all surveys, plans, es-5 timates, specifications and contracts for all proposed work, 6 and shall, except as otherwise provided in this chapter, 7 advertise for bids for the same in two or more public news-8 papers printed wholly or in part in the state, also in one 9 public newspaper printed wholly or in part in the county 10 where the proposed work is to be done, if any such news-11 paper is so printed in such county; such advertisement shall 12 state the place where the bidders may examine the plans 13 and specifications, and the time and place where the bids 14 for such work will be received by the commission. Each 15 bidder must accompany his bid with a certified check or 16 surety bond, payable to the treasurer of state, for ten per 17 cent. of the amount of his bid as a guarantee that if the 18 work is awarded to him he will contract with the commis-19 sion for its due execution; such checks or surety bonds 20 sha'l be returned to the respective unsuccessful bidders.

21 The check or bond of the successful bidder shall be re-22 turned to him upon the execution and delivery to the com-23 mission of his contract and his bond with sufficient sure-24 tres, in terms satisfactory to the commission for the due 25 execution of such work. All bids so submitted shall be 26 publicly opened, read and posted at the time and place 27 stated in such advertisement. The commission shall have 28 the right to reject any and all bids if in its opinion good 29 cause exists therefor, but otherwise it shall award the con-30 tract to the lowest responsible bidder. Any town may 31 submit bids for state and state aid highway construction 32 within its limits, and sha'l be subject to all requirements 33 prescribed for other contractors, except that no bond need 34 be required of it. If all bids for work under this chapter 35 are rejected, or if no bids are received, the commission may 36 perform said work by any method which the governor and 37 council approve. The commission may, however, with the 38 approval of the governor and council, let contracts for state 30 highway construction, or do the same, for and in behalf 40 of the state without advertising for bids if the same shall 41 be for the best interests of the state. The commission 42 shall have full power in all matters relating to the fur-43 nishing of bonds by the successful bidders for the comple-44 tion of their work and fulfilling of their contracts, and for 45 the protection of the state and town from all liability aris-46 ing from damage or injury to persons or property. The 47 commission after making surveys, plans and estimates for 48 proposed construction of state aid highways in a town 49 may when deemed by said commission advisable, make 50 contracts with such town according to said survey and 51 specifications and upon terms satisfactory to and under 52 control of the commission without advertising said con-53 tracts for bids.'
