STATE OF MAINE

IN THE YEAR OF OUR LORD ONE THOUSAND
NINE HUNDRED AND TWENTY-ONE

AN ACT Additional to Chapter Thirty-three of the Revised Statutes, as Amended, Prohibiting Hunting in Certain Territory in the Town of Fairfield, in the County of Somerset.

Be it enacted by the People of the State of Maine, as follows:

Section 1. No person shall, except as herein provided, at
2 any time, hunt, pursue, shoot at or kill any wild animal or
3 any game or wild bird within the following described terri-
4 tory situated in the town of Fairfield, in the county of
5 Somerset:

Good Will Farm, so-called; the Girls' Farm, so-called, of
2 Good Will Farm; land of G. W. Hinckley; land of John
3 Connor; land of J. Russell Barrett, which land is bounded
4 as follows:

On the north by land of Edwin Hicks and N. E. Bessey;
2 on the east by the Kennebec river; on the south by land of
3 Fred Tobey, Frank Moore, H. B. Hamm and C. B. Tuttle,
4 also by the Fairfield Town Farm; on the west by land of
5 L. P. Gifford, Alonzo Hoxie, Edwin Marcou and also by
6 Martin stream; said territory being Good Will Farm proper,
7 so-called, the Girls' Farm, so-called, and land of G. W.
8 Hinckley, John Connor and J. Russell Barrett, adjacent to
9 the above named farms.

It shall also be unlawful for any person to have in posses-
2 sion at any time any wild animal or any game or wild bird or
3 part thereof, taken in violation of any provision of this act.

Provided, however, that the provisions of this act shall
2 not prohibit any person residing within the limits of either
3 of the above described reservations or preserves from shoot-
4 ing at or destroying any wild bird (except ruffed grouse or
5 Hungarian partridge) or any wild animal (except beaver)
6 when found destroying his property; and provided, further,
7 that the provisions of this section shall not be construed to
8 prohibit the trapping of fur-bearing animals within the above
9 described territory in accordance with the general laws of
10 the state.

Sect. 2. Whoever violates any provision of this act shall
2 be subject to a penalty of not less than ten nor more than
3 three hundred dollars and costs for each offense or impris-
4 onment for sixty days, or both said fine and imprisonment.
