STATE OF MAINE

IN THE YEAR OF OUR LORD ONE THOUSAND NINE HUNDRED AND TWENTY-ONE

AN ACT to Amend Sections Two, Seven and Thirteen of Chapter One Hundred Eighty of the Private and Special Laws of Eighteen Hundred and Sixty-nine, as Amended by Sections One, Two and Three of Chapter Five of the Private and Special Laws of Eighteen Hundred and Ninetynine, Relating to Annual Meetings of Protestant Episcopal Churches of the Diocese of Maine.

Be it enacted by the People of the State of Maine, as follows:
Section I. Section two of "An Act to provide for the
2 organization of parishes of the Protestant Episcopal Church
3 in Maine," approved February twenty-six, eighteen hundred
4 and sixty-nine, amended by section one of chapter five of
5 the private and special laws of eighteen hundred and ninety-

6 nine, is hereby further amended by striking out the last six 7 words, namely, "in the first week in Advent," and inserting 8 in place thereof the words 'at such time in January as such 9 parish shall designate,' so that said section as amended shall 10 read as follows:

'Sect. 2. Said agreement shall also contain, first, the name 2 or title by which the parish shall be known, which shall be 3 as follows, namely: The rector, wardens and vestrymen of 4 church in; but no parish shall 5 be organized in any town or city, bearing the same name 6 with any other Protestant Episcopal church already or-7 ganized therein; second, the town or city and county in 8 which it is located; third, the number of vestrymen, not 9 exceeding eleven, and the time of the annual meeting, which 10 shall be at such time in January as such parish shall desig-11 nate.'

Sect. 2. Section seven of said act, as amended by section 2 two of said chapter five of the private and special laws 3 of eighteen hundred and ninety-nine, is hereby further 4 amended by striking out the words "in the first week in 5 advent as may have been agreed upon" and inserting in 6 place thereof the words 'in January as such parish shall 7 designate,' so that said section as amended shall read as 8 follows:

'Sect. 7. The annual meeting shall take place at such 2 time in January as such parish shall designate, and at such 3 annual meeting an election of the requisite number of ward4 ens and vestrymen shall be had, to serve until the next 5 annual meeting, and until their successors shall be chosen.'

Sect. 3. Section thirteen of said act, as amended by sec-2 tion three of chapter five of the private and special laws 3 of eighteen hundred and ninety-nine, is hereby further 4 amended by striking out the words "in the first week in 5 Advent" in the seventh line of said section and inserting in 6 place thereof the words 'in January,' so that said section as 7 amended shall read as follows:

'Sect. 13. Upon such execution, acknowledgment and 2 recording of such agreement, such parish shall, without 3 further action, be deemed to all intents and purposes re-4 organized, and all rights of property and of contract shall 5 remain unimpaired, and the corporate identity of such par-6 ish shall continue unchanged. The wardens and vestry-7 men in office shall continue therein until the annual election 8 in January next following such reorganization, and until 9 a new board shall be chosen, and no other meeting or no-10 tice shall be necessary to complete such reorganization; 11 provided, that when a new board shall be chosen, it shall 12 consist of the number of vestrymen required by such arti-13 cles of reorganization.'
