IN THE YEAR OF OUR LORD ONE THOUSAND  
NINE HUNDRED AND TWENTY-ONE

AN ACT to Provide for the Appointment of a Treasurer and Resident Auditor at the University of Maine, and Define Their Duties.

---

Be it enacted by the People of the State of Maine, as follows:

Section 1. The governor with the advice and consent of  
2 the council shall appoint a full time treasurer of the Uni-  
3 versity of Maine for a term of four years, who shall give  
4 bond for the faithful performance of his duties in such  
5 amount and with such conditions and sureties, and shall re-  
6 ceive such compensation as the governor and council may  
7 determine.

Sect. 2. All appropriations by state and federal govern-

2 ment shall be disbursed for the benefit of the department  
3 or departments for which they are designated, and said  
4 treasurer shall have no authority to contract debts or obli-  
5 gations in excess of said appropriations, nor under any con-  
6 ditions use moneys so appropriated for the benefit of any  
7 other department or departments, unless same is duly and  
8 properly authorized by the governor and council. Said  
9 treasurer shall have full charge of the purchases of all sup-  
10 plies, materials and equipment for the use of the University,  
11 receipts of all moneys and of all expenditures, said payments  
12 to be made when certified by the state auditor.

Sect. 3. The treasurer shall prepare a complete report for  
2 the periods ending on June thirtieth and December thirty-  
3 first of each year, and forward a copy of said semi-annual  
4 report of the department to the governor and council and  
5 also the board of trustees.

Sect. 4. The state auditor shall appoint a resident auditor  
2 for the University of Maine, whose duties shall be to audit  
3 the accounts, and perform such other work as may be re-  
4 quired of him, under direction and by the state auditor,  
5 suitable office quarters to be furnished by the university.  
6 The salary and just expenses of the resident auditor to be  
7 paid from the state auditor's appropriations.
