STATE OF MAINE

IN THE YEAR OF OUR LORD ONE THOUSAND
NINE HUNDRED AND TWENTY-ONE

RESOLVE, Making an Appropriation for Co-operative Agri-
cultural Work between the College of Agriculture of the
University of Maine and the United States Department of
Agriculture.

Resolved: That there be, and hereby is, appropriated to
2 be paid to the University of Maine for co-operative agri-
3 cultural work between its college of agriculture and the
4 United States Department of Agriculture, as such work
5 is defined in an act of the Congress of the United States,
6 approved May eighth, nineteen hundred and fourteen, en-
7 titled "An Act to provide for co-operative agricultural work
8 between the agricultural colleges in the several states re-
9 ceiving the benefits of an act of congress, approved July
10 second, eighteen hundred sixty-two, and acts supplementary

11 thereto, and the United States Department of Agriculture,"
12 for the fiscal year to begin July first, nineteen hundred and
13 twenty-one, the sum of thirty-seven thousand three hun-
14 dred dollars and thirty-six cents, made up of State Smith-
15 Lever regular twenty-six thousand three hundred twenty-
16 nine dollars and sixty-six cents and Smith-Lever Supple-
17 mentary ten thousand nine hundred seventy dollars and sev-
18 enty cents; and for the fiscal year beginning July first,
19 nineteen hundred twenty-two, the sum of forty thousand
20 nine hundred fifty-seven dollars and twenty-eight cents,
21 made up of Smith-Lever regular twenty-nine thousand nine
22 hundred eighty-six dollars and fifty-eight cents and Smith-
23 Lever Supplementary ten thousand nine hundred seventy
24 dollars and seventy cents.

STATEMENT OF FACTS

The State of Maine has already assented to the provisions and requirements of the Act of Congress mentioned in the Resolve. (Chapter sixty, resolves of nineteen hundred and fifteen.)

Contingent upon appropriations by the state, in amounts as stated in the resolve, namely, of \$37,300.36, and \$40,957.28, the United States will pay to the University of Maine for co-operative agricultural work between its College of Agriculture and the United States Department of Agriculture, for the United States fiscal year of 1921-22, \$47,300.36, and for the fiscal year of 1922-23, \$50,957.28.
