STATE OF MAINE

IN THE YEAR OF OUR LORD ONE THOUSAND NINE HUNDRED AND TWENTY-ONE

AN ACT to Amend Section One of Chapter One Hundred and Thirty-nine of the Private and Special Laws of Eighteen Hundred and Ninety-nine, as Amended by Chapter One Hundred and Forty-five of the Private and Special Laws of Nineteen Hundred and Fifteen, Amending the Charter of the Dixfield Village Corporation by Extending the Territory of Said Corporation.

Be it enacted by the People of the State of Maine, as follows:

Section one of chapter one hundred and thirty-nine of the

private and special laws of eighteen hundred and ninety
nine, as amended by chapter one hundred and forty-five of

the private and special laws of nineteen hundred and fifteen,

5 is hereby amended so that said section as amended shall 6 read as follows:

'Section 1. The land in said town of Dixfield embraced 2 within the following limits: Commencing at a point in the 3 center of Webb river at the southwest corner of the Charles 4 G. Delano farm, so-called; thence easterly by the southerly 5 line of said Delano farm to the county road leading from 6 Dixfield village to Carthage; thence southerly and bounded 7 by said county road to the public highway leading from 8 said county road to the Ira O. Babb farm, so-called; thence 9 easterly and bounded by said public highway to the north-10 west corner of the pasture owned by Ira O. Babb; thence II southerly and bounded by the Ira O. Babb pasture, the 12 Davenport pasture, the Marble pasture and the Randall pas-13 ture to the northwest corner of the Cyrus W. Bartlett pas-14 ture; thence easterly by said Bartlett pasture north line to 15 the homestead farm of George G. Gates; thence southwest-16 erly on the line between said Bartlett pasture and said 17 George G. Gates' homestead farm to the public highway 18 leading from Dixfield village past the house of Leroy R. 19 Hall, over the hill, so-called; thence easterly and southerly 20 by said highway to the Ephraim Marble farm; thence south-21 westerly on the line between said Marble farm and said 22 George G. Gates' homestead farm to the Androscoggin river, 23 thence up the northerly bank of said Androscoggin giver 24 to Webb river and thence up said Webb river to the bound 25 begun at, together with the inhabitants thereon, be and the 26 same is hereby created a body politic and corporate by the 27 name of the Dixfield Village Corporation, subject to the 28 other provisions of chapter one hundred and thirty-nine of 29 the private and special laws of eighteen hundred and ninety-30 nine.'
