## STATE OF MAINE

## IN THE YEAR OF OUR LORD ONE THOUSAND NINE HUNDRED AND TWENTY-ONE

AN ACT Amending Certain Sections of Chapter One Hundred and Ninety-seven of the Public Laws of Nineteen Hundred and Seventeen and Chapter One Hundred and Seventy-two of the Public Laws of Nineteen Hundred and Nineteen and Chapter Nineteen of the Revised Statutes, Relating to the State Department of Health.

Be it enacted by the People of the State of Maine, as follows:
Section I. Section seven of chapter one hundred ninety2 seven of the public laws of nineteen hundred seventeen is
3 hereby amended by striking out said section and inserting
4 in place thereof the following:

'The commissioner of public health shall receive an an-2 nual salary to be fixed by the governor and council.'

Sect. 2. Section eight of chapter one hundred and ninety-2 seven of the public laws of nineteen hundred and seventeen, 3 as amended by the public laws of nineteen hundred and 4 nineteen, is hereby amended by striking out the word "thirty-5 eight" in the first line thereof, and substituting therefor the 6 word 'forty-six'; so that said section as amended shall read 7 as follows:

'The sum of forty-six thousand dollars shall be annually 2 appropriated for the purposes set forth in sections one to 3 six inclusive and section seven of said act.'

Sect. 3. Section two of chapter one hundred and seventy-2 two of the public laws of nineteen hundred and nineteen, 3 enacting section sixteen as an additional section to chapter 4 one hundred and ninety-seven of the public laws of nine-5 teen hundred and seventeen, is hereby amended by striking 6 out the word 'thirty' in the first line of said section sixteen, 7 and substituting therefor the word 'thirty-five'; so that said 8 section sixteen as amended shall read as follows:

"The sum of thirty-five thousand dollars shall be appro-2 priated annually to the state department of health for the 3 purposes of carrying out the provisions of sections six, ten, 4 eleven, twelve and thirteen."

Sect. 4. Chapter nineteen of the revised statutes as amend-2 ed by chapter three hundred and one of the public laws of 3 nineteen hundred and seventeen, and as further amended

4 by chapter one hundred and seventy-two of the public laws 5 of nineteen hundred and nineteen is further amended in 6 section one hundred and thirty-one thereof by striking out 7 in the fourth line of said section one hundred and thirty-8 one the word "eight," and substituting therefor the word 9 'ten'; so that said section one hundred and thirty-one as 10 amended shall read as follows:

'For the purpose of enabling the state board of health to 2 carry out the provisions of this act, there is hereby appro-3 priated the sum of ten thousand dollars annually.'

Sect. 5. No part of the increase in appropriations herein 2 provided shall be used for the purpose of increasing the 3 salary of any person except the health commissioner in the 4 public health department.
