#### STATE OF MAINE

## IN THE YEAR OF OUR LORD ONE THOUSAND NINE HUNDRED AND TWENTY-ONE

RESOLVE, in Favor of the Northern Maine Sanatorium,
Presque Isle, Aroostook County.

Emergency Preamble: Whereas the change in the fiscal year, made by statute in nineteen hundred and nineteen, leaves the six months from January first, nineteen hundred and twenty-one, to June thirtieth, nineteen hundred and twenty-one, a period for which an appropriation to be available, must be made as an emergency and, whereas the appropriation of money for the said six months is an emergency measure and is necessary for the public peace, health and safety, now therefore

Resolved: That there be, and hereby is, appropriated for 2 the Northern Maine Sanatorium:

For personal services, namely, for salaries and wages of 2 all officers and employees except those wholly engaged in 3 repairs of buildings and equipment, the sum of six thou-4 sand five hundred dollars for the period from January first, 5 nineteen hundred and twenty-one to June thirtieth, nine-6 teen hundred and twenty-one; the sum of thirteen thousand 7 dollars from July first, nineteen hundred and twenty-one 8 to June thirtieth, nineteen hundred and twenty-two; and 9 the sum of thirteen thousand dollars from July first, nine-10 teen hundred and twenty-two to June thirtieth, nineteen hundred and twenty-three.

For maintenance, namely all articles of food and all other 2 materials, supplies and expenses incident to maintenance 3 of the institution and the patients thereof, whether present 4 or absent, the sum of six thousand six hundred and fifty-5 four dollars and thirty-eight cents for the period from Jan-6 uary first, nineteen hundred and twenty-one to June thir-7 tieth, nineteen hundred and twenty-one; the sum of thirteen 8 thousand three hundred and eight dollars and seventy-five 9 cents for the period from July first, nineteen hundred and 10 twenty-one to June thirtieth, nineteen hundred and twenty-11 two; and the sum of thirteen thousand three hundred and 12 eight dollars and seventy-five cents for the period from July 13 first, nineteen hundred and twenty-two to June thirtieth, 14 nineteen hundred and twenty-three.

In view of the emergency cited in the preamble, this re-2 solve shall take effect when approved.

#### STATEMENT OF FACTS

The Northern Maine Sanatorium was established in Presque Isle, Aroostook county, in 1919, and was opened for patients in October, 1920. A new building, fully equipped, was constructed providing quarters for about twenty patients. Since the opening the building has been full of patients and splendid work has been done. The amounts asked for in this resolve were suggested by the board of trustees as being necessary for carrying on the work in an efficient manner, and are the same amounts as recommended by the budget committee.
