STATE OF MAINE

**IN THE YEAR OF OUR LORD ONE THOUSAND
NINE HUNDRED AND TWENTY-ONE**

RESOLVE, in Favor of the National Conference of Commissioners on Uniform State Laws and of the Commissioners from Maine for the Promotion of Uniformity of Legislation in the United States.

Resolved: That the sum of one hundred fifty dollars
2 (\$150) for the period from January first, nineteen hundred
3 and twenty-one, to June thirtieth, nineteen hundred and
4 twenty-one, and the sum of five hundred dollars (\$500)
5 for the period from July first, nineteen hundred and twenty-
6 one, to July first, nineteen hundred and twenty-two, and
7 the sum of five hundred dollars (\$500) for the period from
8 July first, nineteen hundred and twenty-two, to July first,
9 nineteen hundred and twenty-three, be and hereby is appro-

10 priated. Two hundred dollars (\$200) for the year begin-
11 ning July first, nineteen hundred and twenty-one, and two
12 hundred dollars (\$200) for the year beginning July first,
13 nineteen hundred and twenty-two, to be paid to the National
14 Conference of Commissioners on Uniform State Laws, and
15 so much of the balance for each year beginning July first,
16 nineteen hundred and twenty-one, and July first, nineteen
17 hundred and twenty-two, and for the six months period be-
18 ginning January first, nineteen hundred and twenty-one, as
19 may be necessary to be paid to the Commissioners from
20 Maine for the Promotion of Uniformity of Legislation in
21 the United States for their expenses in attending the Na-
22 tional Conference of Commissioners on Uniform State
23 Laws, for drafting and printing reports, postage, and for
24 their other expenses in performing the duties of said office.
25 All as recommended in report of the committee on budget.

And whereas the fiscal year of the State of Maine now
2 ends on June thirtieth and no money is available under a
3 regular appropriation for the first six months of the year
4 nineteen hundred and twenty-one, and

Whereas the appropriation for the first six months in
2 nineteen hundred and twenty-one as aforesaid is an emer-
3 gency measure immediately necessary for the preservation
4 of the public peace, health and safety,

Therefore be it resolved, that this resolve shall take effect
2 when approved.
