#### STATE OF MAINE

## IN THE YEAR OF OUR LORD ONE THOUSAND NINE HUNDRED AND TWENTY-ONE

AN ACT to Amend Section Seventy-six of Chapter Eightytwo of the Revised Statutes, Relative to Price of Maine Reports.

Be it enacted by the People of the State of Maine, as follows:

That section seventy-six of chapter eighty-two of the re-

- 2 vised statutes as amended by chapter two hundred and
- 3 eighty of the public laws of nineteen hundred and seven-
- 4 teen, is hereby amended by striking out in the eighth line
- 5 of said section after the words "price of" the words "two
- 6 dollars and fifty cents" and inserting in place thereof the
- 7 words 'three dollars a volume in buckram binding, and four
- 8 dollars a volume in leather binding,' so that said section as
- 9 amended shall read as follows:

'Sect. 76. The reporter of decisions shall, by his personal 2 attendance at law court when practicable, or by the best 3 other means in his power, prepare correct reports of all 4 legal questions argued and decided, reporting cases more 5 or less at large according to his judgment of their import-6 ance. He shall publish at least one volume yearly, pro-7 vided he has material enough to make a volume of the size 8 required by this section, and furnish the usual number of 9 current copies to the state and to the public at the price 10 of three dollars a volume in buckram binding, and four 11 dollars a volume in leather binding. Each volume shall 12 be of the average size of volume eighty-three, Maine Re-13 ports, and be equal thereto in paper, printing, general fin-14 ish and quantity of printed matter. The reporter may from 15 time to time, as he sees fit, make a written contract in his 16 own name with any person, firm or corporation for the 17 printing, publishing and binding of said reports and shall 18 require such person, firm or corporation to give a good 19 and sufficient bond with good and sufficient sureties, condi-20 tioned for the faithful performance of all the terms and 21 conditions of such contract by the person, firm or corpora-22 tion with whom the reporter makes such contract. In case 23 of a breach of any or all the conditions of such bond, the 24 reporter may maintain an action on such bond in his own 25 name.'
