STATE OF MAINE

IN THE YEAR OF OUR LORD ONE THOUSAND
NINE HUNDRED AND TWENTY-ONE

AN ACT to Abolish the Board of Public Works of the City of
Lewiston and to Provide for a Highway Commission.

Be it enacted by the People of the State of Maine, as follows:

Section 1. A commission to be known as the Lewiston
2 Highway Commission is hereby established in and for the
3 city of Lewiston, which shall have and exercise all the pow-
4 ers and be charged with all the duties relative to the con-
5 struction, maintenance, care and control of the streets, high-
6 ways, bridges, sidewalks, drains and sewers in said city,
7 subject, however, to the general laws of the state.

Sect. 2. Said commission shall consist of three members,
2 all of whom shall be a resident of said Lewiston, and each

3 member shall be sworn by the city clerk of said city to the
4 faithful discharge of his duties, and shall hold his office as
5 hereinafter provided unless removed by a justice of the su-
6 preme judicial or superior court for cause.

Sect. 3. No member of said commission shall be eligib'e
2 to the city council or hold any city office. No member of
3 the commission or the superintendent of streets shall take
4 any active part in politics. Any violation shall be consid-
5 ered cause for removal.

Sect. 4. The commission shall, as soon as this act takes
2 effect, organize by the choice of one of its members as chair-
3 man, and shall elect a secretary, whose duty it shall be to
4 keep a record of the proceedings of the commission, to no-
5 tify members of meetings and perform such other duties as
6 the commission may elect.

Sect. 5. The commission shall also elect a superintendent
2 of streets and sewers, who shall have executive charge of
3 work under the direction and control of said commission.
4 Said superintendent may contract for necessary labor and
5 materials, subject at all times to the approval of the com-
6 mission, to whom he shall render an account, monthly or
7 oftener if required of all receipts, expenditures and out-
8 standing bills.

Sect. 6. Said commission shall make a schedule of all
2 the supplies, tools, materia's and property received by them,
3 and of all additions that shall from time to time be made
4 to the same, and shall enter an inventory thereof in a book

5 kept for that purpose. Any and all books of accounts and
6 records shall be subject to inspection by the city auditor
7 and such books of accounts and records may be kept in such
8 manner and form as said auditor may direct.

Sect. 7. The weekly pay roll and all matters requiring
2 payment of money from the city treasurer shall be approved
3 by some member of the commission, or the clerk, after ap-
4 proval and before payment, they shall be sent to the said
5 auditor for his approval. The commission shall at all times
6 keep a correct list of all persons employed in the street de-
7 partment together with the amount of wages paid and a
8 duplicate list of the same shall be filed with the auditor.

Sect. 8. The commissioners shall receive a salary of one
2 thousand dollars per annum, payable in equal monthly in-
3 stallments by the city treasurer, said sum shall be in full
4 compensation for all services.

Sect. 9. The compensation of the superintendent of streets
2 and sewers, and also that of the clerk or clerks shall be
3 fixed by said commissioners and shall be paid from an ap-
4 propriation made by the city council for the work of the
5 commission.

Sect. 10. Members of the commission shall be appointed
2 by the mayor, one for a term of eight years, one for six
3 years, and one for four years. Vacancies occurring during
4 a term shall be filled for the unexpired term. The commis-
5 sion shall annually choose a chairman from its members,
6 and in case of failure to make such choice, the mayor shall

7 appoint the chairman. The city solicitor shall be attorney
8 for said commission and shall without additional compen-
9 sation give the commission such advice and service as it
10 may from time to time require.

Sect. 11. Proceedings for removal of said commissioners
2 shall be brought on petition of a majority of the city council
3 and shall be heard as provided in section two of this act, the
4 decision of the justice hearing a petition for removal shall
5 be final.

Sect. 12. All acts and parts of acts inconsistent with this
2 act are hereby repealed.
