## STATE OF MAINE

# IN THE YEAR OF OUR LORD ONE THOUSAND NINE HUNDRED AND TWENTY-ONE

AN ACT to Amend Section Fifty-seven of Chapter Thirtythree of the Revised Statutes, as Amended by Chapter Two Hundred and Nineteen of the Public Laws of Nineteen Hundred and Seventeen, and Further Amended by Chapter Sixtyone of the Public Laws of Nineteen Hundred and Nineteen, Relating to the Protection of Wild Birds.

Be it enacted by the People of the State of Maine, as follows:

3 birds," amended. Section fifty-seven of chapter thirty-three
4 of the revised statutes, as amended by chapter two hundred
5 and nineteen of the public laws of nineteen hundred and
6 seventeen, and further amended by chapter sixty-one of the

7 public laws of nineteen hundred and nineteen, is hereby
8 amended by inserting after the word "provided" in the
9 eleventh line thereof, the following words: 'provided further
10 that the sea gull may be killed while in the act of destroying
11 property,' so that said section shall read as follows:

'Sect. 57. Commissioners may grant permits to kill wild 2 birds which have become injurious to agricultural or other 3 interests. No person shall within the state, kill or catch 4 or have in his or her possession, living or dead, any wild 5 bird, other than a game bird, nor purchase, offer or expose 6 for sale, any such wild bird, after it has been killed or caught. 7 No part of the plumage, skin or body of any bird protected 8 by this section shall be sold or had in possession for sale. 9 Nor shall any person take or needlessly destroy the nest or 10 the eggs of any wild bird, nor have such nest or eggs in his II possession. The English or European house sparrow, the 12 common crow, and the hawks and owls, mud hens (or bit-13 tern), kingfishers, loons, and blue herons are not included 14 among the birds herein protected; provided further that the 15 sea gull may be killed while in the act of destroying prop-16 erty; and for the purpose of this chapter the following only 17 shall be considered game birds: The anatidae commonly 18 known as swans, geese, brant, and river and sea ducks; the 19 rallidae, commonly known as rails, coots, and gallinules; the 20 limicolae, commonly known as shore birds, plovers, surf 21 birds, snipe, woodcock, sandpipers, tatlers, and curlews; 22 the gallinae, commonly known as wild turkeys, grouse,

23 prairie chickens, pheasants, partridges and quails. Nothing 24 in this section, however, shall be construed to affect in any 25 way the protection of game birds as provided in sections 26 fifty-four and fifty-five. Provided, however, that the com-27 missioner of inland fisheries and game shall have authority 28 upon complaint that protected wild birds, under extraordi-29 nary conditions, have become seriously injurious to agricul-30 ture or other interests in any particular community, after 31 thorough investigation, to grant permits to kill such birds. 32 Any person who violates any of the provisions of this sec-33 tion shall pay a fine of five dollars and costs, for each of-34 fense, and an additional five dollars for each bird, living or 35 dead, or part of a bird, or nest or egg, possessed in violation 36 of this section, or be imprisoned for ten days.'
