STATE OF MAINE

**IN THE YEAR OF OUR LORD ONE THOUSAND
NINE HUNDRED AND TWENTY-ONE**

RESOLVE, in Favor of the Public Utilities Commission, to Take Care of Expenses Provided for Under Chapter One Hundred and Seventeen, Section Thirty-one, Chapter Fifty-five, Section One, and Chapter Twenty-four, Sections Thirty-four to Thirty-eight of the Revised Statutes.

Resolved: That there be, and hereby are, appropriated
2 for and in behalf of the Public Utilities Commission the fol-
3 lowing sums for the following purposes, namely:

For the period between January first, nineteen hundred
2 and twenty-one and June thirtieth, nineteen hundred and
3 twenty-one, for salaries and clerk hire (chapter one hundred
4 and seventeen, section thirty-one; chapter fifty-five, section

5 one, of the revised statutes) twenty-one thousand seven
6 hundred and fifty dollars; for the period beginning July first,
7 nineteen hundred and twenty-one and ending June thirtieth,
8 nineteen hundred and twenty-two, the sum of forty-three
9 thousand five hundred dollars for the same purposes; for
10 the period beginning July first, nineteen hundred and twen-
11 ty-two and ending June thirtieth, nineteen hundred and
12 twenty-three, the sum of forty-three thousand five hundred
13 dollars for the same purposes.

For the period beginning January first, nineteen hundred
2 and twenty-one and ending June thirtieth, nineteen hundred
3 and twenty-one, for general office expenses (chapter fifty-
4 five, section one, revised statutes) the sum of five thousand
5 two hundred and fifty dollars; for the period beginning July
6 first, nineteen hundred and twenty-one and ending June
7 thirtieth, nineteen hundred and twenty-two, the sum of ten
8 thousand five hundred dollars for the same purposes; for
9 the period beginning July first, nineteen hundred and twen-
10 ty-two and ending June thirtieth, nineteen hundred and
11 twenty-three, the sum of ten thousand five hundred dollars
12 for the same purposes.

For the period beginning January first, nineteen hundred
2 and twenty-one and ending June thirtieth, nineteen hundred
3 and twenty-one, for grade crossing purposes (chapter twen-
4 ty-four, sections thirty-four to thirty-eight, revised statutes)
5 the sum of five thousand dollars; for the period beginning
6 July first, nineteen hundred and twenty-one and ending

7 June thirtieth, nineteen hundred and twenty-two, for the
8 same purposes, the sum of ten thousand dollars; for the
9 period beginning July first, nineteen hundred and twenty-
10 two and ending June thirtieth, nineteen hundred and twen-
11 ty-three, the sum of ten thousand dollars for the same pur-
12 poses.
