STATE OF MAINE

**IN THE YEAR OF OUR LORD ONE THOUSAND
NINE HUNDRED AND TWENTY-ONE**

AN ACT to Authorize Emery-Waterhouse Company of Portland to Bring Suit in the Name of the State of Maine Against Alfred Hanson and Son and the Massachusetts Bonding and Insurance Company on Contract and Accompanying Bond for Construction of Building at State School for Girls.

Be it enacted by the People of the State of Maine, as follows:

Section 1. The Emery-Waterhouse Company, a corporation duly organized under the laws of this state, is hereby authorized to use the name of the State of Maine for the purpose of bringing suit against Alfred Hanson and Son of Augusta in the county of Kennebec, and the Massachusetts Bonding and Insurance Company, a corporation organized under the laws of Massachusetts and engaged in

8 a surety bonding business in the State of Maine, or either
9 of them, to recover any sum or sums alleged to be due un-
10 der, or by reason of any breach of, a contract under date
11 of September twenty-six, nineteen hundred and seventeen,
12 between said Alfred Hanson and Son and the State of
13 Maine, for the erection of a central school building for
14 the state school for girls at Hallowell, Maine, or under a
15 bond given to secure said contract, under date of October
16 second, nineteen hundred and seventeen, to the State of
17 Maine, signed by said Alfred Hanson and Son, and the
18 said Massachusetts Bonding and Insurance Company, so far
19 as said Emery-Waterhouse Company may have any legal
20 or equitable rights under said contract or bond.

Sect. 2. Said Emery-Waterhouse Company, by availing
2 itself of the provisions of this act, shall assume full con-
3 trol of any action which it may institute in the name of
4 the state and shall hold the state harmless from all cost and
5 expense in connection therewith; and the attorney general
6 shall not be required to appear therein.
