### STATE OF MAINE

## IN THE YEAR OF OUR LORD ONE THOUSAND NINE HUNDRED AND TWENTY-ONE

AN ACT to Amend Sections One and Five of Chapter One Hundred Sixty-nine of the Public Laws of Nineteen Hundred Nineteen, Relating to the Support of Dependents of Soldiers, Sailors and Marines.

Be it enacted by the People of the State of Maine, as follows:

Section 1. Section one of chapter one hundred sixty-nine

- 2 of the public laws of nineteen hundred nineteen is hereby
- 3 amended so that said section, as amended, shall read as fol-
- 4 lows:

'Section 1. The cities, towns and plantations in this state

- 2 shall raise money by taxation or otherwise to be applied to re-
- 3 lieve the necessitous circumstances of the wife, children un-
- 4 der the age of sixteen years, the infirm and dependent father,

5 mother or other member of the family incapable of self-6 maintenance, of any soldier, sailor or marine who served in 7 the World War; provided, that on April first, nineteen hun-8 dred seventeen, such soldier, sailor or marine was a resi-9 dent of this state. The money so raised shall be paid direct-10 ly to the dependents entitled thereto under the provisions 11 of this act, or to the parent or legal guardian of any such 12 dependents who are minors or under guardianship, by the 13 municipal officers of the cities, towns and plantations where-14 in such dependents respectively reside, in sums not exceed-15 ing four dollars a week to relieve the necessitous circum-16 stances of the wife, infirm and dependent father or mother 17 of such soldier, sailor or marine, and a sum not exceeding 18 one dollar and fifty cents a week to relieve the necessitous 19 circumstances of each child under the age of sixteen years 20 or other member of the family incapable of self-mainte-21 nance, who is dependent upon such soldier, sailor or marine; 22 provided, however, that the sum so paid shall not in any 23 case exceed ten dollars a week for all persons entitled there-24 to under the provisions of this act by reason of their re-25 lationship and dependency upon one soldier, sailor or ma-26 rine, and such money in the same amounts shall be furnished 27 to relieve the necessitous circumstances of any of the afore-28 said relatives of any such soldier, sailor or marine killed in 29 battle, or dying or becoming disabled as a result of the cas-30 ualties of war or of sickness contracted in the line of his 31 duty, and not of his own fault. The moneý authorized to 32 be raised under this act shall be available only to inhabi33 tants of the aforesaid cities, towns and plantations of the 34 State of Maine on the said first day of April, nineteen hun-35 dred and seventeen, but any persons entitled to receive aid 36 hereinunder shall not forfeit the same by reason of tem-37 porary absence from the state. All officials charged with 38 duties under this act shall, in determining the question of 39 dependency and necessitous circumstances, duly consider 40 federal insurance and federal compensation in lieu of in-41 surance, federal allotment and federal allowance and any 42 and all other provisions made by either state or federal gov-43 ernment or any divisions or departments thereof for the 44 same or similar purposes contemplated by this act.'

Sect. 2. Section five of said chapter one hundred sixty-2 nine is hereby amended so that said section, as amended, 3 shall read as follows:

'Sect. 5. Such accounts shall be made up to the first days 2 of July and January in each year, and shall be filed with the 3 governor and council on or before the first days of August 4 and February following and shall be examined and passed 5 upon within a reasonable time after the date of such filing. 6 If approved, the amounts allowed shall be paid, upon war-7 rants drawn by the governor and council against any money 8 in the treasury appropriated for that purpose, by the state 9 treasurer to the city, town or plantation whose claim has 10 been thus established.'
