STATE OF MAINE

IN THE YEAR OF OUR LORD ONE THOUSAND NINE HUNDRED AND TWENTY-THREE

AN ACT to Amend Chapter Two Hundred Ninety-four of the Public Laws of Nineteen Hundred Seventeen, as Amended by Chapter Sixty-three of the Public Laws of Nineteen Hundred Twenty-one, Relating to Seizure and Forfeiture of Vehicles Carrying Intoxicating Liquors Intended for Illegal Sale.

Be it enacted by the People of the State of Maine, as follows:

Chapter two hundred ninety-four of the public laws of

- 2 nineteen hundred seventeen, as amended by chapter sixty-
- 3 three of the public laws of nineteen hundred twenty-one,
- 4 is hereby amended by adding thereto the following words:
 - 'Any right, interest or title of any person or corporation

2 other than the person or persons in possession or control 3 of any such automobile, truck, wagon, boat, vessel or ve-4 hicle shall also be forfeited unless the possession or con-5 trol of the person using the same for the unlawful trans-6 portation aforesaid shall be without the knowledge of the 7 person or corporation claiming such right, interest or title. 'Any claimant of any right, interest or title in such auto-2 mobile, truck, wagon, boat, vessel or vehicle must allege 3 and prove that the possession and control of the same was 4 without his knowledge or consent or the knowledge or con-5 sent of any person holding title under or by virtue of a 6 contract with him,' so that said section as amended shall 7 read as follows:

'Claim that boat or vehicle was being used without consent 2 of owner not a defense. All automobiles, trucks, wagons, 3 boats or vessels, and vehicles of every kind, not common 4 carriers, containing intoxicating liquors intended for illegal 5 sale within the state, found within the state in the pos-6 session or in the control of any person using them for the 7 transportation of intoxicating liquors intended for illegal 8 sale within the state, shall be seized by any officer seizing 9 the liquors transported therein, shall be libelled as is pro-10 vided for the libeling of intoxicating liquors and the vessels 11 in which they are contained under chapter one hundred 12 and twenty-seven of the revised statutes, and shall be de-13 clared forfeited by the court and sold in the same manner

14 as is provided for the sale of vessels containing intoxi-15 cating liquors.

'Any right, interest or title of any person or corporation 2 other than the person or persons in possession or control 3 of any such automobile, truck, wagon, boat, vessel or ve-4 hicle shall also be forfeited unless the possession or con-5 trol of the person using the same for the unlawful trans-6 portation aforesaid shall be without the knowledge of the 7 person or corporation claiming such right, interest or title.
