STATE OF MAINE

IN THE YEAR OF OUR LORD ONE THOUSAND NINE HUNDRED AND TWENTY-THREE

AN ACT to Amend Chapter Thirty-seven of the Private and Special Laws of Nineteen Hundred Seventeen as Amended by Chapter One Hundred Twenty-four of the Private and Special Laws of the Special Session of Nineteen Hundred Nineteen, Relating to the Salaries of Chief of Police and Police Captains of the City of Lewiston.

Be it enacted by the People of the State of Maine, as follows:

Section r. That section fifteen, chapter one hundred
2 twenty-four, of the private and special laws of the special
3 session of nineteen hundred nineteen, be amended by strik4 ing out the words "twenty-one hundred dollars" and the

5 figures "(\$2100)" in the second line of said section, and

6 inserting in lieu thereof the words 'twenty-four hundred 7 dollars' and the figures '(\$2400),' so that said section as 8 amended shall read as follows:

'Sect. 15. Salary increased from \$2100 to \$2400. That 2 the salary of the chief of police shall be twenty-four hun-3 dred dollars (\$2400) per annum, payable in equal weekly 4 instalments by the city treasurer. The chief of police shall 5 be entitled to two weeks vacation each calendar year (with 6 pay) the same to be taken when and as he may desire. 7 While upon such vacation or when incapacitated through 8 illness or absent from his office on the business of the degratment, the duties of his position shall be assumed by the 10 senior captain.'

Sect. 2. That section sixteen, chapter one hundred 2 twenty-four, of the private and special laws of the special 3 session of nineteen hundred nineteen, be amended by strik-4 ing out the words "eighteen hundred dollars" and the 5 figures "(\$1800)" in the second line of said section, and 6 inserting in lieu thereof the words 'twenty-one hundred 7 dollars' and the figures '(\$2100)' so that said section as 8 amended shall read as follows:

'Sect. 16. Salary increased from \$1800 to \$2100. Police 2 captains shall each receive a salary of twenty-one hundred 3 dollars (\$2100) per annum, payable in equal weekly instalments by the city treasurer, and be entitled to a vacation of 5 two weeks each calendar year (with pay) such vacation to 6 be prescribed by the chief of police.
