STATE OF MAINE

IN THE YEAR OF OUR LORD ONE THOUSAND NINE HUNDRED AND TWENTY-THREE

AN ACT to Amend Chapter Twenty-five of the Revised Statutes of Maine, 1916 Revision, as Enlarged and Amended by Chapter Two Hundred Fifty-eight of the Public Laws of the State of Maine for the year Nineteen Hundred Seventeen, by Chapter Two Hundred Twenty of the Public Laws of Maine for the Year Nineteen Hundred and Nineteen, and by Chapter Two Hundred Sixty-three of the Public Laws of Maine for the Year Nineteen Hundred Nineteen as Enacted at the Special Session of the Legislature, Held November 4-8, 1919, Relative to State Highways and to the Creation and Expenditure of the Mill Tax Highway Fund.

Be it enacted by the People of the State of Maine, as follows:

Section I. Chapter two hundred fifty-eight of the pub-2 lic laws of nineteen hundred seventeen added a section, to 3 be known as section thirty-six, to chapter twenty-five of the 4 revised statutes of 1916, as theretofore amended. Chapter 5 two hundred twenty of the public laws of 1919 amended 6 said section thirty-six as was in said chapter indicated. 7 Chapter two hundred sixty-three of the public laws of nine-8 teen hundred nineteen, special session November 4-8, 1919, 9 amended said chapter two hundred twenty of the public laws 10 of 1919 as set forth in said chapter two hundred sixty-three. 11 Said chapter two hundred sixty-three, public laws of 1919, 12 special session, is hereby amended as follows: on pages 13 thirty, thirty-one and thirty-two of the acts passed at said 14 special session, as printed in the special laws enacted at said 15 session, appears sections one, two, three, four, five, six, 16 seven and eight. Section one on page thirty is hereby 17 amended by striking out in the fourth line thereof the words 18 "or maintenance or both of" and substituting therefore the 19 words 'of third class'; further, by adding after the words 20 "revised statutes" in the fifth line thereof, the words 'except 21 that if any town at its annual meeting, by a two-thirds vote 22 so orders, any portion of such fund may for any particular 23 year be diverted from the construction of third class roads 24 and be used for the construction of second class or state 25 aid roads as defined by statute and in the manner provided 26 by statute'; and by striking out of said section in the fifth 27 line thereof between the words "not more than" and the

28 words "of the fund" in the sixth line the words "one-sixth" 29 and substituting therefor the words 'one hundred thousand 30 dollars'; so that said section as amended shall read as fol-31 lows: 'A tax of one mill on a dollar shall annually be 32 assessed on all the property of the state according to the 33 true value thereof, and shall be known as the mill tax high-This fund shall be used for the construction of 34 way fund. 35 third class highways as defined in section five of chapter 36 twenty-five of the revised statutes, except that if any town 37 at its annual meeting by a two-thirds vote so orders, any 38 portion of such fund may for any particular year be diverted 39 from the construction of third class roads and be used for 40 the construction of second class or state aid roads as defined 41 by statute, and in the manner provided by statute; except 42 that not more than one hundred thousand dollars of the 43 fund shall be annually used for the construction of high-44 ways and bridges and other purposes contemplated by said 45 chapter twenty-five and in accordance with the terms of any 46 appropriate resolve of the legislature.'

Sect. 2. Section thirty-four of chapter twenty-five of the 2 revised statutes, revision of 1916, and section two of chap-3 ter two hundred sixty-three of the public laws of nineteen 4 hundred nineteen, special session (meaning that section on 5 page thirty of the published laws beginning with the words 6 "one-third of the mill tax highway fund") are hereby re-7 pealed and the following substituted therefor as section 8 thirty-four of chapter twenty-five of the revised statutes:

9 'Section thirty-four. There shall be appropriated annually 10 the sum of three hundred thousand dollars, which together 11 with the mill tax highway fund as provided in section one 12 of this act of nineteen hundred twenty-three shall be known 13 as the third class highway fund.'

Sect. 3. Section three of chapter two hundred and sixty-2 three of the public laws of 1919, special session November 3 4-8, (being that section beginning at the bottom of page 4 thirty in the published report of the laws of that session) 5 is hereby amended by striking out all of said section after 6 the word "apportioned" in the third line thereof, and sub-7 stituting therefor the following: 'Among the various towns 8 according to the number of miles of third class roads con-9 tained therein as determined by the highway commission, 10 provided that such towns shall have appropriated for the II current year in addition to the appropriation for state aid 12 work and appropriation under the so-called bridge act an 13 amount not less than four mills on the valuation of such 14 town,' so that such section as amended shall read as follows: 15 'Section three. The administration and expenditure of the 16 third class highway fund shall be under the general super-17 vision of the state highway commission and shall be appor-18 tioned among the towns according to the number of miles 19 of third class roads contained therein, as determined by the 20 highway commission, provided that such towns shall have 21 appropriated for the current year in addition to the appro-22 priation for state aid work and appropriation under the so23 called bridge act, an amount not less than four mills on the 24 valuation of such town.'

Sect. 4. Section four of said chapter two hundred sixty-2 three public laws of 1919, special session November 4-8 3 (being the section four found upon page thirty-one of the 4 published laws of said special session) is hereby amended 5 by striking out the word "September" in the fourteenth line 6 thereof and substituting therefor the word 'October,' so 7 that said section as amended shall read as follows: 'Mu-8 nicipal officers of any town may, prior to October one in 9 any year, file with the state highway commission the descrip-10 tion or location of the road whose construction and im-II provement they recommend under the provisions of this 12 act. Upon approval of said location by the state highway 13 commission, the municipal officers shall proceed with the 14 construction of a section upon said location in conformity 15 with the provisions of the following section of this act. 16 After acceptance by the state highway commission of a 17 location as above, construction shall be continued on that 18 location until the entire length of the road has been con-19 structed or until the location is changed. Upon the com-20 pletion of any road located as above, municipal officers shall 21 file with the state highway commission recommendation for 22 location upon another road. The work performed under 23 this act shall be completed before the thirtieth day of 24 October annually, and in no case shall any of the third class 25 highway fund be expended upon a section of a road where

26 the buildings are nearer than two hundred feet apart for a 27 distance of one-fourth of a mile or more.'

Sect. 5. Section eight of said chapter two hundred sixty-2 three of the public laws of 1919, special session November 3 4-8 (being the section eight found upon page thirty-two of 4 the published report of the public laws of said session) is 5 hereby repealed.

Sect. 6. The apportionment of the third class highway 2 fund herein created shall be made in accordance with the 3 returns which shall have been made by the several towns 4 desiring participation on or before April fifteenth of each 5 year, and no town whose selectmen or other officials have 6 not made the returns required by the state highway depart-7 ment on or before said April fifteenth shall be entitled to 8 any apportionment of said fund.

Sect. 7. If any town at its annual meeting by a two-thirds 2 vote so orders, any portion of the fund for third class roads 3 herein created may be for any particular year diverted from 4 the construction of third class roads and be used for the 5 construction of second class or state aid roads as defined 6 by statute and in the manner provided by statute. Until 7 such time as other provision is made by bond issue or other-8 wise for financing the construction of second class or state 9 aid roads, any town may at its annual meeting vote to set 10 apart not to exceed fifty per cent of the amount to be appor-11 tioned to said town under the provisions of this act for the 12 purpose of improving its second class or state aid roads, 13 provided such town shall appropriate an equal amount for 14 the same purpose.

Sect. 8. This act shall take effect on the first day of 2 January, nineteen hundred and twenty-four.
